O R D E R

Out of an allotment of 414.995 K.L of S.K. Oil for the month of August-2018 allocated by Govt. in Food Supplies & Consumer Welfare Department., Odisha, Bhubaneswar vide Letter No. 13597 / dated. 09.07.2018, a stock of 403.472 K.L of S.K.Oil as per FPS wise distribution order downloaded from NFSA web portal for the month of August -2018 is allotted to different Blocks among the Wholesalers of this District for lifting & distribution of the same as per the norms and conditions stipulated by Govt. for supply of K. Oil by the IOCL.

As per Government direction S.K. Oil will be distributed only to Ration Card holders (both for PHH & AAY Ration Card holder) of the district on per card per month @ 2.5 Ltrs. through e-Pos device.

The FPS-wise sales register also been made available for download in the e-PoS devices of those Fair Price Shops which have received the device to carry out PoS based distribution of S.K Oil entitlement of beneficiaries. This should be downloaded in PoS Device after 1st date of the allotment month and distribution should be made accordingly through PoS Device.

Further, Minimum 25% verification of sale will be conducted by the Inspector of Supplies/Marketing Inspectors/Asst. Civil Supplies Officers in-charge of the Blocks/ULB positively.

Un-distributed allotment of S.K.Oil will be considered as opening balance while finalizing the allotment for the next month.
