The Desk Appraisal Committee Meeting for finalization of NGO for Management of PHC(N) Project in different blocks was held on 05.07.2019 at 4.30 PM under the Chairmanship of CDM & PHO Kandhamal, The list of participants attended the meeting is at **Annexure – A.**

The CDM&PHO, Kandhamal briefed that for Selection of NGO for management of PHC(N) under PPP Mode an open advertisement was floated at the State level on 07/02/2019 in the daily newspaper “The Samaj”, “The Sambad” and “The Indian Express” inviting expression interest from the credible NGOs/Trusts/company/Institutions for management 6 Nos of PHC(N) under PPP mode with last date for receiving of EOI was latest by 06th March 2019. The details of the PHC(N) are as follows.


Name of the NGO	Reason for Rejection
OVHA.	The Bidder OVHA was rejected due to non submission of Original Affidavit regarding “never blacklisted/ debarred from participating in any tender process by any state Govt./ Central Govt. Institutions in form of T5”.
PRDATA	The Bidders PRDATA was rejected as the fixed asset is less than 10 Lakhs & Not submitted the Annual reports of last three years.

After a detail discussion the above two NGOs were not considered for scoring and the scoring was done for the rest 7 nos . of NGOs. The detail scoring of the 7 Nos. of NGOs is as follows which is at Annexure – K, L, M, N, O, P & Q.






