OFFICE ORDER

And whereas the Government of Odisha, in exercise of powers conferred under Section-2, 3 and 4 of the Epidemic Diseases .Act, 1897, has framed the Odisha COVID-19 Regulation, 2020 for prevention and containment of Corona virus disease, 2019(COVID-19).

And whereas the Government of Odisha, vide Revenue & DM(Disaster Management) Department Notification No. 170 of 'R&DM Dated 13. 03.2020, has declared COVID- 19 as a 'Disaster' under section 2(d) of the Disaster Management Act, 2005 for the state of Odisha.

In the present scenario, as there is steep rise of CORONA positive cases in Hotspot districts and there is regular in flow of people from hotspot districts to Kandhamal for various purposes because of which the urban population faces high exposure to this returnees / frequently moving people from hotspot districts. Considering the number of symptomatic cases arising day by day, high contamination is apprehended. In the view of public Health interest and in order to assess the viral load in Kandhamal, District Administration Kandhamal have decided to conduct door to door health screening of urban population and the population in the town areas apart from the containment areas. So to retain the public in their home for successful health surveillance, in pursuance of the said orders and in exercising the power conferred by the Disaster Management Act, 2005 of Epidemic Disease Act, 1897.1, Dr. Brundha D, IAS, Collector & District Magistrate, Kandhamal, in compliance to different norms do hereby impose the following restrictions.

- 1. Shutdown is extended for two days in the entire jurisdiction of Kandhamal district on 27.07.2020(Monday) and 28.07.2020(Tuesday). The weekend shutdown imposed vide Lt.no.1872,dt.01/07/2020 will remain in force on Saturday(25.07.2020) and Sunday(26.07.2020)
- 2. All the entry points to the town areas and exit from there are hereby restricted completely for the period of 4 days i.e from 25.07.2020 (5 AM) until midnight of 28.07.2020
- 3. In emergency cases vehicles will be allowed to ply subject to permission of concerned Sub-Collector.
- 4. Movement of public transport, Private vehicles and taxis for plying for non essential activities are to be restricted completely.
- 5. Road transport and highway is permissible without boarding and de boarding at ULB.

- 6. The restriction is not applicable to agriculture, horticulture, fisheries, animal husbandry, veterinary services and allied activities.
- 7. The movement of government officials in emergency duty will be allowed subject to production of government ID card.

The concerned IIC is directed to check the movement of public during that period of restrictions by deploying adequate police personnel at different strategic locations.

Concerned BDO's /concerned E.Os and DI&PRO, Phulbani are directed to make wide publicity in the locality for information of the public through public address system.

The concerned Tahasildar will act as Executive Magistrate in his jurisdiction.

This order will come into force with effect from 25th of July (5Am).
