The Govt. in Food Supplies & Consumer Welfare Department, Odisha, Bhubaneswar vide letter No. 10575 / dated, 02.07.2020 have allotted a stock of **636 K.L** S.K. Oil for both NFSA & SFSS beneficiaries allotted to different Blocks through the Wholesalers of this District for lifting & distribution of the same as per the norms and conditions stipulated by Govt. for supply of K. Oil by the IOCL for the period from **September & October, 2020**.

As per Government direction S.K. Oil will be distributed to the NFSA & SFSS Ration Card holders of the district @ 2.000 Ltrs. per card per month through e-Pos device.

The FPS-wise sales register also been made available for download in the e-PoS devices of those Fair Price Shops which have received the device to carry out PoS based distribution of S.K Oil entitlement of beneficiaries. This should be downloaded in PoS Device after 1st date of the allotment month and distribution should be made accordingly through PoS Device.

The allotted quota of SK Oil for September & October, 2020 should be lifted immediately and distributed to NFSA beneficiaries within 30th September, 2020.

Further, **Minimum 25% verification** of sale of S.K. Oil will be conducted by the **Inspector of Supplies/ Marketing Inspectors/ Asst. Civil Supplies Officer's in-charge of the Blocks/ULB positively.**

The Un-distributed allotment of S.K. Oil will be considered as opening balance while finalizing the allotment for the next month.

The Wholesalers / Retailers are directed to lift the allotted stock as per the dateline positively. Stringent action should be taken against the wholesalers / retailers who are not lifting the allotted stock in full and indulged in Black-marketing and diversion of PDS Kerosene for any other purpose and Wide publicity should be given about scale of supply of K. Oil and consumers selling price so that consumers will get actual quantity in notified price.
