OFFICE ORDER


In pursuance of the provision of Odisha Village Level Workers (Recruitment and Condition of Services) Rule 2008 as amended in 2012 and 2013 and instruction of Government in Panchayati Raj And Drinking Water Department vide Notification No. 47214/PR dated 11.12.2008 read with Resolution No. 4947/PR dated 07.02.2009, letter No. 11530/PR dated 20.04.2013, Letter No. 5465/PR dated 31.03.2017 and Letter No. 10453 dated 12.06.2017 the following Gram Panchayat Secretary of Kandhamal district is selected by the District Selection Committee in the meeting held on 15.09.2020 is hereby appointed as Panchayat Executive Officer (PEO) and posted in the Block as mentioned on contractual basis temporarily with monthly remuneration of Rs. 9,000/- (Rupees Nine thousand) only as per Notification No. 28090/F dated 22.09.2017 of Finance Department and Notification No. 32010/Gen. dated 12.11.2013 of General Administration Department, Odisha with the following terms and conditions.

1. The engagement is subject to verification of certificate / document at the time of joining of the candidates. If any discrepancy in verification of original certificates/ documents is located, his joining report shall not be accepted and his engagement is liable to be cancelled.
2. The engagement is purely temporary and terminable at any time without notice and assigning any reason thereof.
3. He shall continue on contractual basis for a period of six years on consolidated remuneration of Rs. 9,000/- (Rupees Nine thousand). The period of six year shall be counted from the date of his contractual engagement.
4. He shall submit written undertaking in the model form prior to his joining.
5. On the date of satisfactory completion of six years of contractual service, he shall be appointed regularly. On regular appointment he will be entitled to draw the time of scale of Pay with D.A and Other Allowances as admissible in the corresponding pay band.
6. Subject to satisfactory performance, the consolidated remuneration of contractual employees shall be enhanced as per slabs prescribed under the Annexure Appended to (Contractual Appointment) Amendment Rules, 2017 on completion of each year of service.
7. He shall not be entitled to draw D.A, H.R.A, RCM and Other Allowances during the period of contractual engagement.
8. He shall be abided by Odisha Civil Service Conduct Rule- 1959 and O.C.S (CC&A) Rule, 1962.

9. He shall be enrolled under the new pension scheme contained in the Odisha Civil Services (Pension) Rule 1992 from the date of his contractual engagement.
10. He should submit the following documents at the time of his joining in the post.
 - i. Medical Certificate of fitness signed by the Government Medical Practitioner not below the rank of Asst. Surgeon.
 - ii. Two Character Certificates from the two Gazetted Officers.
 - iii. Original Certificate in support of his qualification and date of birth/ caste / residence/ Physical Handicapped identity card where applicable.
 - iv. Oath of allegiance to the constitution of India.
11. The engagement will stand automatically cancelled if he does not join the post within seven days from the date of receipt of this engagement order.
12. Declaration to the effect that they have not having more than one spouse living (if married).


