And whereas, the National Disaster Management Authority (NDMA), Government of India in exercise of powers conferred under section 6 (2)(i) of Disaster Management Act, 2005 has directed the State Government/ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National executive Committee constituted under the said Act to issue necessary guideline in this regard.

And whereas, Government of Odisha has issued various measures to contain the spread of COVID-19 vide order No.2444/R&DM (DM) dated.03.05.2020.

And whereas, **01** (**One**) positive Covid case have been identified from Chitrakuta Sahi of FCI in ward no.09 under Phulbani Municipality. For effective containment and surrounding Zone for monitoring of COVID related preventive measures it is inevitable to declare the containment zone. Now therefore, in larger public interest and with a view to contain to spread of COVID-19, I, Dr. Brundha D, IAS Collector and District Magistrate, Kandhamal being the Empowered officer do hereby order the following.

 The area coming within the boundary as indicated below (Map enclosed) is hereby declared as-

Containment Zone – Chitrakuta Sahi of FCI in ward no.09.

- The areas mentioned above under Phulbani Municipality are hereby declared as containment Zone. The boundaries of Containment Zone are as per the Trace map attached herewith. The movement of people inside the Containment Zone or to and From Containment Zone is strictly prohibited.
- The IIC, Town PS, Phulbani is directed to create a temporary check post at entry and exit point of Chitrakuta Sahi of FCI in ward no.09 to regulate the entry and exit from the Containment Zone.
- The Superintendent of Police, Kandhamal is requested to provide adequate manpower and logistic support for the check posts at the marked point.
- Sri. Dinamani Naik, Tahasildar Phulbani is hereby deployed as Executive Magistrate and overall in-charge of containment Zone.
- 6. Smt, Nibedita Swain ,Penjisahi UP School, (Mob-9437429298) and Smt Birojini Mahapatra, Penjisahi UP School (Mob-9439022575) is hereby deployed as Nodal officer of containment zone. They are directed to ensure the following (i) create awareness among the public regarding COVID-19 Norms (ii) motivate and mobilize the people to come forward for COVID testing (iii) following of home isolation guidelines (iv) Zero movement of people in the containment zone.

- All vehicular movement, Movement of public transport and Personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned.
- All inhabitants within the containment shall strictly remain in home. All shopping establishment whatsoever nature shall be closed immediately. The supply of essential and medical requirement will be ensured through various teams under the Sub-Collector. Phulbani.
- 9. The CDM & PHO, Kandhamal is directed to complete house to house screening and swab collection of active contacts and shifting of positive patients immediately. Intensive surveillance mechanism as outline in the Standard Operating Protocol (SOP) issued by MoHFW shall be established with in the containment Zone. The local authority shall ensure 100% coverage of Aarogya Setu App/Swasthya App among the resident of containment zone. In the containment following activities shall be undertaken by the local authorities.
 - Contact Tracing.
 - Home/ institutional quarantining of individual based on assessment by medical officers. This risk assessment will be based on symptoms, contact with confirmed cases and travel history.
 - Testing of all cases with severe acute respiratory infections (SARI) influenza like illness (ILI) and other symptoms specified by MoHFW.
 - House to house surveillance by special team constituted for this purpose.
 - · Clinical management of all cases as per protocol.
 - Counseling and educating people and establishing effective communicate.
- 10. The EO, Municipality, Phulbani is requested to barricade the entries and exit of the Containment Zone and to engage service providers for all essential services(Vegetables, Groceries, medicines, etc) at door step of the people.
- 11. The Station officer Phulbani Fire Station is directed to fumigate and sanitize all the areas in Containment zone .
- 12. The C.D.P.O. Phulbani is requested to provide all the help to the E.O., Municipality Phulbani and Medical Officer, Phulbani for providing of service in connection with health screening at Containment zone.
- 13.In Containment Zone, There shall be strict perimeter control to ensure that there is no movement of population in or out of the zone except for medical emergencies and for maintaining supply of essential goods and services. The guidelines issued in this regard by MoHFW will be strictly implemented.
- 14. Activities in Containment Zone:
 - Strict perimeter control
 - · Establishment of clear entry and exit points
 - Movement of persons only for maintaining supply of goods and services and for medical emergencies.
 - No unchecked influx of people and transport.
 - Recording of details of people moving in and out of the perimeter.

15.Daily reporting is to be submitted by the CDM & PHO, Phulbani, Kandhamal to the undersigned with reference to the L.No. 10611/H dtd. 04.05.2020 of Principal Secretary to Govt. H & FW Department, Odisha, Bhubaneswar.

The order will remain in force from today till modified or revoked by the undersigned.
