Whereas, the Government of Odisha vide Revenue & Disaster Management (Disaster Management) Department Notification No.1706/R&DM (DM) dated.13.03.2020 has declared COVID-19 as a "DISASTER" under Section 2 (d) of disaster Management Act.2020 by virtue of the power conferred under section 2, 3 and 4 of epidemic disease Act, 1897 for containment of COVID-19.

And whereas, the National Disaster Management Authority (NDMA), Government of India in exercise of powers conferred under section 6 (2)(i) of disaster management Act, 2005 has directed the State Government/ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National executive Committee constituted under the said Act to issue necessary guideline in this regard.

And whereas, Government of Odisha has issued various measures to contain the spread of COVID-19 vide order No.2444/R&DM (DM) dated.03.05.2020.

And whereas, **03 (Three) positive Covid cases have been identified from Bhagamunda Sahi under Balliguda NAC** for effective containment and surrounding Zone for monitoring of COVID related preventive measures is quite essential. Now therefore, in larger public interest and with a view to contain to spread of COVID-19, I Dr. Brundha D, IAS Collector and District Magistrate, Kandhamal being the Empowered officer do hereby order the following.

1. The area coming within the boundary as indicated below (Map enclosed) is hereby declared as-  
**Containment Zone :**  
**Bhagamunda Sahi under Balliguda NAC.**
2. The areas mentioned above under Balliguda NAC are hereby declared as containment Zone. The boundaries of Containment Zone are as per the Trace map attached herewith. The movement of people inside the Containment Zone or to and From Containment Zone is strictly prohibited.
3. The IIC, Balliguda PS is directed to create a temporary check post at **entry and exit point of Bhagamunda Sahi** to regulate the entry and exit from the Containment Zone.
4. The Superintendent of Police, Kandhamal is requested to provide adequate manpower and logistic support for the check posts at the marked point.
5. Sri Shashanka Sekhar Patra, Tahasildar Balliguda is hereby deployed as Executive Magistrate and overall in-charge of containment Zone.
6. Sri Jayapal Singh, JSE is hereby deployed as Nodal officer of containment zone .He is directed to ensure the following (i) create awareness among the public regarding COVID 19 Norms (ii) motivate and mobilize the people to come forward for COVID testing (iii) following of home isolation guidelines (iv) Zero movement of people in the containment zone (v) 100% active surveillance by the assigned team in the containment zone.
7. All vehicular movement, Movement of public transport and Personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned.
8. All inhabitants within the containment shall strictly remain in home. All shopping establishment whatsoever nature shall be closed immediately. The supply of essential and medical requirement will be ensured through various teams under the Sub-Collector, Balliguda.
9. All the Government offices, Private institutions and private sectors including banks located within the boundary of containment Zone are hereby closed herewith except the offices/ institutions associated with emergency duties.



10. The CDM & PHO, Kandhamal is directed to complete house to house screening and swab collection of active contacts and shifting of positive patients immediately. Intensive surveillance mechanism as outline in the **Standard Operating Protocol (SOP)** issued by MoHFW shall be established with in the containment Zone. The local authority shall ensure 100% coverage of Aarogya Setu App/Swasthya App among the resident of containment zone. In the containment following activities shall be undertaken by the local authorities.

- Contact Tracing.
- Home/ institutional quarantining of individual based on assessment by medical officers. This risk assessment will be based on symptoms, contact with confirmed cases and travel history.
- Testing of all cases with severe acute respiratory infections (SARI) influenza like illness (ILI) and other symptoms specified by MoHFW.
- House to house surveillance by special team constituted for this purpose.
- Clinical management of all cases as per protocol.
- Counseling and educating people and establishing effective communicate.

11. The EO, Balliguda NAC is requested to barricade the entries and exit of the Containment Zone and to engage service providers for all essential services at door step of the people.

12. The Station officer Balliguda Fire Station is directed to fumigate and sanitize all the areas in Containment Zone.

13. The C.D.P.O. Balliguda is requested to provide all the help to the EO, Balliguda NAC and Medical Officer, CHC Balliguda for providing of service in connection with health screening at Containment Zone respectively.


14. In Containment Zone, There shall be strict perimeter control to ensure that there is no movement of population in or out of the zone except for medical emergencies and for maintaining supply of essential goods and services. The guidelines issued in this regard by MoHFW will be strictly implemented.

15. Activities in Containment Zone:

- Strict perimeter control
- Establishment of clear entry and exit points
- Movement of persons only for maintaining supply of goods and services and for medical emergencies.
- No unchecked influx of people and transport.
- Recording of details of people moving in and out of the perimeter.

He is directed to ensure the following (i) create awareness among the public regarding COVID 19 Norms (ii) motivate and mobilize the people to come forward for COVID testing (iii) following of home isolation guidelines (iv) Zero movement of people in the containment zone (v) 100% active surveillance by the assigned team in the containment zone.
7. All vehicular movement, Movement of public transport and Personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned.
8. All inhabitants within the containment Zone shall strictly remain in home. All shopping establishment whatsoever nature shall be closed immediately. The supply of essential and medical requirement will be ensured through various teams under the Sub-Collector, Balliguda.




9. All the **Government Offices/ Private institutions /Public sectors including Banks** located within the boundary of containment Zone except those associated with emergency duties are hereby closed herewith.
10. The CDM & PHO, Kandhamal is directed to complete house to house screening and swab collection of active contacts and shifting of positive patients immediately. Intensive surveillance mechanism as outline in the **Standard Operating Protocol (SOP)** issued by MoHFW shall be established with in the containment Zone. The local authority shall ensure 100% coverage of Aarogya Setu App/Swasthya App among the resident of containment zone. In the containment following activities shall be undertaken by the local authorities.
- Contact Tracing.
  - Home/ institutional quarantining of individual based on assessment by medical officers. This risk assessment will be based on symptoms, contact with confirmed cases and travel history.
  - Testing of all cases with severe acute respiratory infections (SARI) influenza like illness (ILI) and other symptoms specified by Mo HFW.
  - House to house surveillance by special team constituted for this purpose.
  - Clinical management of all cases as per protocol.
  - Counseling and educating people and establishing effective communicate.
11. The B.D.O. Raikia is requested to barricade the entries and exit of the Containment Zone and to engage service providers for all essential services at door step of the people.
12. The Station officer Raikia Fire Station is directed to fumigate and sanitize all the areas in Containment Zone.
13. The C.D.P.O. Raikia is requested to provide all the help to the B.D.O. Raikia and Medical Officer, CHC Raikia for providing of service in connection with health screening at Containment Zone respectively.
14. In Containment Zone, There shall be strict perimeter control to ensure that there is no movement of population in or out of the zone except for medical emergencies and for maintaining supply of essential goods and services. The guidelines issued in this regard by MoHFW will be strictly implemented.
15. Activities in Containment Zone:
- Strict perimeter control
  - Establishment of clear entry and exit points
  - Movement of persons only for maintaining supply of goods and services and for medical emergencies.
  - No unchecked influx of people and transport.
  - Recording of details of people moving in and out of the perimeter.





**ORDER**

Whereas, the Government of Odisha vide Revenue & Disaster Management (Disaster Management) Department Notification No.1706/R&DM (DM) dated.13.03.2020 has declared COVID-19 as a "DISASTER" under Section 2 (d) of disaster Management Act,2020 by virtue of the power conferred under section 2, 3 and 4 of epidemic disease Act, 1897 for containment of COVID-19.

And whereas, the National Disaster Management Authority (NDMA), Government of India in exercise of powers conferred under section 6 (2)(i) of disaster management Act, 2005 has directed the State Government/ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National executive Committee constituted under the said Act to issue necessary guideline in this regard.

And whereas, Government of Odisha has issued various measures to contain the spread of COVID-19 vide order No.2444/R&DM (DM) dated.03.05.2020.

And whereas, **01 (One) positive Covid case has been identified from Ugamunda village of Letingia GP under K. Nuagaon Block**, for effective containment and surrounding Zone for monitoring of COVID related preventive measures is quite essential. Now therefore, in larger public interest and with a view to contain to spread of COVID-19, I Dr. Brundha D, IAS Collector and District Magistrate, Kandhamal being the Empowered officer do hereby order the following.

1. The area coming within the boundary as indicated below (Map enclosed) is hereby declared as-  
**Containment Zone area:**  
**Ugamunda village of Letingia GP.**
2. The areas mentioned above under K. Nuagaon Block are hereby declared as containment Zone. The boundaries of Containment Zone are as per the Trace map attached herewith. The movement of people inside the Containment Zone or to and From Containment Zone is strictly prohibited.
3. The IIC, Sarangada PS is directed to create a temporary check post at **entry and exit of Ugamunda village** to regulate the entry and exit from the Containment Zone.
4. The Superintendent of Police, Kandhamal is requested to provide adequate manpower and logistic support to ensure strict containment of the area.
5. Sri. Manoj Kumar Debata, Tahasildar K. Nuagaon is hereby deployed as Executive Magistrate and overall in-charge of containment Zone.
6. Sri Pramod Kumar Sahani, PEO is hereby deployed as Nodal officer of containment zone .He is directed to ensure the following **(i)** create awareness among the public regarding COVID 19 Norms **(ii)** motivate and mobilize the people to come forward for COVID testing **(iii)** following of home isolation guidelines **(iv)** Zero movement of people in the containment zone **(v)** 100% active surveillance by the assigned team in the containment zone.
7. All vehicular movement, Movement of public transport and Personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned.





13. The C.D.P.O. K. Nuagaon is requested to provide all the help to the B.D.O. K. Nuagaon and Medical Officer, BPHO K. Nuagaon for providing of service in connection with health screening at Containment Zone respectively.
14. In Containment Zone, There shall be strict perimeter control to ensure that there is no movement of population in or out of the zone except for medical emergencies and for maintaining supply of essential goods and services. The guidelines issued in this regard by MoHFW will be strictly implemented.




