Sealed Quotations are hereby invited from the intending Reputed Indian Brand Company (GST Registered company/firms) who desire to supply a coffee Brewing and Beverage Vending Machine (as per specification enclosed) to be used for management of Cafeteria in the premises of Collectorate, Kandhamal.

The sealed quotation should reach on or before 24.2.2022 at 4.00 PM in the District Social Welfare Office, Kandhamal, Phulbani through registered/speed post/ courier only. No quotation will be received by hand or by any other means. The cover containing quotation papers should be superscribed as " QUOTATION FOR SUPPLY OF COFFEE BREWING & BEVERAGE VENDING MACHINE FOR COLLECTORATE CAFETERIA"

The quotation will be opened by the Committee on 25.2.2022 at 1 PM in presence of the Quotationers or his/her authorized Agent in the office chamber of the DSWO, Kandhamal. If no body is present from the side of the Quotationers at the scheduled date and time, the committee will not wait for opening of the quotation.

Quotations will not be accepted/entertained after expiry of the due date and time as above. The interested Suppliers/firms should submit the Technical Bid and Financial bid separately in one sealed envolpe. All the pages of the quotation papers should be signed with seal of the firms/agencies. The rate should be quoted in the prescribed format separately for each item.

The quotations should accompany with the following documents.

Technical bid.

1. E.M.D. of Rs. 2,000/- ( Rupees Two thousand) only in shape of Bank draft in favour of the District Social Welfare Officer, Kandhamal.
2. Photocopy of valid Pan card, GST registration certificate, upto date GST clearance, Income Tax return of last year i.e. 20-2021 should be furnished alongwith the quotation papers.

Financial bid

3. The rate should be quoted inclusive of all taxes i.e. GST, Entry Tax etc. as per Govt. guideline in the prescribed format for each item.

Other Terms and conditions.

4. Sample of items are to be produced before the committee at the time of opening of quotation for verification.
5. No extra cost will be given for transportation of the items. The rate is negotiable. Supply is to be made at Dist. Social Welfare Office, Kandhamal.
6. The quotation will be summarily rejected if sample and above required documents are not produced.
7. Any legal dispute arises out of this subject to jurisdiction of Kandhamal only.
8. The agency should have not been blacklisted by any Govt. organization, if found later, the action shall be initiated against the firm as per law.

The bids are liable to be rejected if any of the above conditions are not complied with proper manner.

The successful quotationer(s) should deliver the approved items within 28.2.2022, failure to deliver within the stipulated period shall result forfeiture of the EMD to Govt. and alternative action will be taken by the authority.
