# I. **ELIGILBILITY OF THE CANDIDATE:**

- (i) The candidate must be a citizen of India
- (ii) Must have passed at least +2 Examination conducted by the Council constituted under Section-3 of the Orissa Higher Secondary Education Act,1982 or equivalent examination of a recognized Council, Board or University, as the case may be;
- (iii) Must at least have passed Diploma in Computer Application (DCA) from a recognized Institute.
- (iv) Must be over 18 years and below 32 years of age as on 03.08.2022, provided that the upper age limit in respect of reserved categories of candidates shall be relaxed in accordance with the provisions of the relevant Act, Rules, Orders or Instructions for the time being in force for the respective reserved categories.
- (v) Must be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to the M.E. standard.
- (vi) Be of good character.
- (vii) Be of sound health, good physique and free from organic defects or bodily infirmity.
- (viii) Have not more than one spouse living, if married.
- (ix) For the post of **Junior Typist** the candidates shall possess a minimum speed of 40 words per minute in Typewriting.
- (x) For the post of **Stenographer**, **Grade-III** the candidates shall possess minimum speed of 80 words in Shorthand and 40 words in Typewriting per minute.
