

Utmost care should be taken at B.E.O level for wide circulation of Gradation List among the Senior Teachers in Level-V (B) concerned through C.R.C.C. The signature of all Senior Teachers in Level-V (B) s shall be obtained in the Gradation List. Further, they are instructed to furnish a certificate to the effect that the Gradation List of Senior Teachers in Level-V (B) has been circulated among all Senior Teachers in Level-V (B) working under their control.

If any, omission and commission in the Gradation List, the objection thereof should be filed within 15 days from the date of issue of this letter by the teacher concerned before their Block Education Officers. The B.E.Os are requested to submit the objection with their compliance for both category separately in the prescribed format –A appended herewith to this office within three days positively for finalization the Gradation List at this end. The objections received after the due time will not be taken into consideration.

Further, you are requested to submit the Information of Teachers come under PH category from initial appointment in the separate format-B duly filled in for taking necessary action.
