The Provisional Gradation list of Assistant Teachers of Level-V (A) of Elementary Teachers as on 01-08-2021 working in different Blocks under administrative control of Kandhamal Education District has been prepared as per the following on the receipt of information/data of such teachers from Block Education Officers as per instruction laid down in Letter No 7729 dated 11.03.2020 and Letter No 10668 dated 28-06-2021 of Director, Elementary Education, Odisha and the Odisha Elementary Education (Method of recruitment and conditions of Services of Teachers and Officers ) Amendment Rules,2019 as notified by Govt. in School and Mass Education Department vide Notification dated 08.03.2019 .

## Level-V (A)

Separate Gradation list of Assistant Teachers in Level-V (A) of the service has been prepared taking into consideration the following qualification and training.

- (i) High School Certificate or Higher Secondary (+2) or Bachelor Degree in any discipline or equivalent examination with Secondary Teachers' Training or Certified Teachers Course or Diploma in Elementary Education and pass in Odisha Teachers Eligibility Test-I. **(Annexure-A)**
- (ii) Bachelor Degree in any discipline or an equivalent examination with Secondary Teachers' Training or Certified Teachers Course of Diploma in Elementary Education or Bachelor in Education and pass in Odisha Teachers Eligibility Test-II. **(Annexure-B)**

Provided that the teachers appointed against the advertisements published prior to 11.02.2011 are exempted from passing Odisha Teachers Eligibility Test-I and Odisha Teachers Eligibility-II.

The gradation list is sent herewith for circulation among the concerned teachers and also hoisted herewith in the District website i.e. @kandhamal.nic.in. Utmost care should be taken at B.E.O level for wide circulation of Gradation List among the teachers concerned working under their control through C.R.C.C. The signature of all Level- (A) Assistant Teachers shall be obtained in the Gradation List. Further, they are instructed to furnish a certificate to the effect that the Gradation List of

Level-V (A) Assistant Teachers has been circulated among all Level-V (A) Assistant Teachers working under their control.

If any, omission and commission in the Gradation List, the objection thereof should be filed in format A **within 15 days** positively by the teacher concerned before their Block Education Officers. The B.E.Os are requested to submit the objection with their compliance for both category separately in the prescribed format appended herewith to this office within three days positively for finalization the Gradation List at this end. The objections received after the due time will not be taken into consideration.

Further, you are requested to submit the Information of Teachers come under PH category from initial appointment in the separate **format-B** duly filled in for taking necessary action.
