03. Creative Artist and Experts from the District (As members of the Odisha Sahitya Academy/ Odisha Sangeet Natak Academy/Odisha lalit Kala Academy). Urdu Academy.
04. Representatives of National/State/District Level Voluntary Organisation which have executed any programme of Scheme within the District. (Strength-06(Six) Numbers).
05. Cultural Co-Ordinator*An Officials or Non-Official person having expertise and experience in organizing /Co-Ordination Cultural Programme.)
06. Special Invites (Selected by the Collector& Chairman, DCC when necessitated by Specific occasions).

The interested Candidates Should submit the application along with required documents to the Collector & Chairman, DCC, Kandhamal through the DCO & Secretary Kandhamal on or before Dted. 22.06.2022 positively. The application will not be received after due date. The Selection procedure of membership of DCC Will be decided in the DCC meeting.
