Applications are invited from the retired employees for re-engagement to the post of ICDS Supervisors and Junior Assistant (Statistics) under Women & Child Development Department in Kandhamal District.

### **1. Eligibility Conditions:**

- (i) Officers who have retired from Govt. service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re-employment.
- (ii) Officers against whom departmental proceedings or criminal cases are contemplated /pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

### **2. Remuneration to be paid:**

Rate of remuneration be paid to ICDS Supervisor is Rs.20000/-P.M(level 9 as per ORSP Rules,2017) and for Junior Assistants(Statistics) is Rs.10000/-P.M (level 4 under ORSP Rules,2017).

### **3. Mode of application:**

Application in enclosed form along with biodata & relevant documents should be sent in a closed cover addressed to the **District Social Welfare Officer, Kandhamal, Pin-762001** by Regd. Post/Speed Post only so as to reach in the office on or before 05.04.2023. The applications received after due date/ courier Service/ by hand shall not be considered.

### **4. Enclosures to be attached to the application form:**


- a. Self attested recent passport size colour photograph to be affixed in the Application Form.
- b. Copy of the retirement order.

### **5. Tenure, Terms and Conditions:**

- (i) The engagement is proposed to be for a period of two years or till regular posting of such base level post, whichever is earlier.
- (ii) However, in case of non-filling up of such base level posts, their engagement may be further extended with the prior approval of Department up to total four years not beyond the age of sixty five years.
- (iii) For the post of Supervisors, retired personnel with past experience in W & CD Department, SSEPD Department, Health Department, School and Mass education, SCSTM&BC Department, PR&DW Department may be considered. Preference may be given to women.



- (iv) For the post of Junior Assistant (Statistics) any retired staff having experience of office work from any Department may be considered. However, preference may be given to those who are skilled with computers.
- (v) All retired employees will be posted only under the administrative control of the DSWO/CDPO offices where ever vacant post is available.
- (vi) Re-employed Officers shall be governed by the provisions of Odisha Government Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (vii) The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one month notice. On the contrary if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.
