Empanelment of Mediators in the District Consumer Disputes Redressal Commission, Kandhamal, Odisha

Applications are invited from eligible candidates for empanelment as Mediators in the District CDR Commission, Kandhamal for a period of five years in prescribed format with the copies of certificates so as to reach the undersigned on or before 19.04.2023 by 5 p.m.The empanelment shall be conducted in accordance with the Provision of the Consumer Protection Act,2019 and as specified in the Consumer Protection(Mediation)Regulations,2020.

The following persons are eligible for empanelment as Mediators:

- 1. Retired judges of a Supreme Court of India
- 2. Retired Judges of High Courts.
- 3. Retired Members of a Consumer Commission.
- 4. Retired District and Session Judges, retired Additional District and Session Judges or other retired Members of the Higher Judicial Services of a State.
- 5. Retired Judicial Officers, having experience of not less then years.
- 6. An Advocate with a minimum experience of ten years at Bar.
- 7. The mediator empanelled with the mediation Cell of the Supreme Court of India, High Court or a District Court.
- 8. A person having experience of at least five years in mediation or conciliation.
- 9. Expert or other professionals with at least fifteen years experience or retired senior bureaucrats or retired executives.

AGE

The above person should be above 30 (thirty) years of age.

Fee of Mediators-

A consolidated fee shall be paid to the empanelled mediator who conducts the mediation proceedings and such fee as may be fixed by the President of this Commission.

Disqualification for empanelment-

- 1. A person who has been adjudged as in solvent.
- 2. Person against whom criminal charted involving moral turpitude are framed by a criminal court and are pending.
- 3. A Person who has been convicted by a criminal court for any offence involving moral turpitude.
- 4. A Person against whom disciplinary proceeding have been initiated by the appropriate disciplinary authority and are pending or have resulted in a punishment.
- 5. A person who has been interested or connected with the subject matter of the consumer dispute or is related/associated in any manner, including in a professional capacity with any of the parties to the consumer disputes or any of their associates shall be disqualified for being nominated as a mediator.

Applications shall be received online through e-Mail of this Commission i.e. districtforumkandhamalphulbani@gmail.com or by Registered/Speed Post so as to reach the undersigned on the date and time mentioned above. Applications shall be received after the scheduled date and time shall be rejected.
