General eligibility:-

- (a) He /She must be a citizen of India.
- (b) He/She must have passed Class-X standard in MIL Odia. In case he/she has not done Odia as a subject upto Class X standard, then he/she should have qualified at the single subject Odia examn. Upto High School standard conducted by the Board of Secondary Education, Cuttack.
- (c) He/she must have successfully completed a Bachelor's Degree with minimum 50% marks in aggregate and B.PEd. from an institution affiliated to a recognised University. Regarding Universities/ institutions of outside State, the candidates shall only be eligible for engagement after verification of genuineness of their educational/training qualification from concerned university/institution from which they have obtained the degree.
- (d) Such outside University/institution pass out candidates shall have to produce the authenticated proof of equivalency and NCTE recognition in support of their qualification at the time of verification failing which their case will not be entertained.
- (e) He/ She must not have more than one spouse living.

1. Age:-

He/she must be below 40 Yrs. and above 21 Yrs. of age as on 31.05.2018 provided that maximum age limit shall be relaxed by 05 Years in case of candidates belonging to ST/SC category.

2. Educational Qualification:

- (a) Trained Graduate Teacher in Health & Physical Education He/she must have obtained bachelor degree certificate in Hons. Or pass subject from a recognised university with minimum 50% marks in aggregate alongwith a degree in Bachelor in Physical Education from an institution affiliated to a recognised university.
- (b) **Catering Assistant** He/she must have obtained Degree or Diploma in Hotel Management from a recognised university with minimum two years relevant experience.

The candidates should have registered their names either in the Employment Bureau located at Vanivihar, Bhubaneswar/ Jyoti Vihar, Sambalpur/Bhanja Vihar, Berhampur/ OUAT, Bhubaneswar or in the State Employment Exchange, Bhubaneswar or in any District Employment Exchange. SC/ST and PH candidates should have registered their name in the Special Employment Exchange for SC/ST & PH at Bhubaneswar or in any Employment Exchange located in the concerned Revenue District which he/ she belongs to.

3. Reservation:-

The Odisha Reservation of Vacancies (In posts and services for ST&SC) Act.,1975 and The Odisha Reservation of Posts & Services for Socially & Educationally Backward Classes Act,2008 and the rules made there under and such other principles of the post based reservation as prescribed by the State Government on the land mark judgement of Hon'ble High Court/Supreme Court, from time to time, shall be followed.

Instructions contained in SSEPD Deptt. Resolution No.7140/Dtd.05.09.2017 shall be adhered to, for (PwD) candidates.

The PH candidates shall be referred to the Appellate Medical Board constituted by W&CD Department vide Notification No.16430/WCD/Dtd.06.09.2011 for re-examination. Engagement order shall be issued if such candidates found genuine by the Board.

Emoluments & Service condition:-

The emoluments and service conditions shall be guided as per the provisions of G.A Deptt. Notification No.32010/Gen./Dtd.12.11.2013 & No.19569/Gen./Dtd.12.09.2017 & No.19574/Gen./Dtd.12.09.2017.

5. Mode of application:

Application complete in all respect along with the relevant documents should be sent in a closed cover addressed to the District Welfare Officer, Kandhamal, At/Po-Kandhamal, Dist. Kandhamal, PIN-762001 by Regd. Post/Speed Post only so as to reach to the office on or before dt. 31.03.2018 at 5.00 PM. The applications received after due date / Courier Service/ By hand shall not be considered.

6. Selection Procedure:-

Selection will be made by the District Selection Committee headed by the Collector, Kandhamal, Phulbani. PA,ITDA, Phulbani/Balliguda/Inspector of Schools (SSD), Kandhamal/ District Education Officer, Kandhamal are members and District Welfare Officer, Kandhamal is Member Convenor of the Committee (as per Govt. in ST&SC Development Deptt. Notification No. 213/OMTES, Dtd.07.6.2018). Selection shall be made only on merit i.e. on the basis of percentage of marks. The selection process will be made in two stages. Firstly, all the application forms meeting the minimum eligibility criteria will be short listed. The short listed applications will be ranked and provided a weightage of 50% for academic achievement and 20% for the relevant work experience. Thereafter all the short listed applicants fulfilling the minimum eligibility criteria shall be called for a Personal Interview in the 2nd stage. The selection Committee should constitute an Interview Board consisting of Dist. Level Officials and experts in the relevant subject. The personal Interview will carry a weightage of 30%. The candidates securing the highest score in the order of merit will be selected. (Letter no. 213/OMTES, Bhubaneswar, dtd.7.6.2018 is attached).

- (i) In case of two or more candidates secured the same marks the candidate older in age will be placed above in the rank.
- (ii) If there is further tie, the higher percentage of marks secured in training qualification will be taken in to account.
- (iii) Higher education will not be given any weight age during preparation of merit list in all categories.
