In continuation to this Department letter No.20422/ dtd.16.08 2019 I am to say that doubts have arisen from different quarters regarding preparation of gradation list of the contractual Staff Nurses & Paramedics of the cadres mentioned in the subject cited above. The instructions as given below in this regard may be appreciated by all concerned for better clarifications.

- (i) That the present gradation list shall be prepared taking into account the eligible contractual staffs only under different schemes for the purpose of notification by name. The present gradation list should not be mixed with the Government contractual / regular staffs.

That the list of Pharmacists as submitted by the MD, OSMCL and the list of Laboratory Technicians as submitted by the Director, S.B.T.C., Odisha have been sent to all Districts to include those names, if found otherwise eligible and if not included earlier. But complaints have been received that after receipt of these lists, CDM&PHOs are not entertaining the names of Pharmacist / LTs already submitted by them under DDC / Blood Bank.

In this regard it is clarified that CDM & PHOs shall examine all cases (names submitted by them as well as the list given by the MD, OSMCL / Director, S.B.T.C., Odisha) and include all of them in the gradation list to be prepared, if they are found eligible.

Madam/ Sir,

With reference to the subject cited above, I am to state that information from the districts as well as from MC & Hs duly countersigned by the Collectors has been received on the actual men-in-position of Staff Nurses & Paramedics who are working in different Health Institutions, and who have been engaged either against regular vacancies or against contractual positions under different schemes/ programmes of Health & FW Department in the format as prescribed earlier. Accordingly, steps have been taken at this level to induct the no of contractual employees engaged under the schemes/ societies against the regular vacancies U/R 4 of the New Recruitment Rule, 2019 of the above 6 categories. Now until and unless, the gradation list of those employees is finalised and unless the employee fulfils all the criteria as mentioned U/R 5 & 9 of the Recruitment Rule, 2019, the regularisation by name can not reach its finality.

As it is extremely important that the gradation list furnished is correct & error-free, it is decided to constitute a Committee comprising of the following officials of the district,
