INVITATION FOR COMPETITIVE BIDDING

1. The Executive Officer, Phulbani Municipality invites sealed Item Rate bids for the sanitation works from Registered Firms/Service Providers/Registered Organization satisfying the eligibility criteria given bid documents who will be the sincere and dedicated in sanitation service.

The tender documents as required by this office along with EMD of Value of **Rs. 3,00,000.00** which is refundable, will be kept as Security money if the service provider is awarded with the contract and the EMD of unsuccessful bidder will be returned. Paper cost will be **Rs. 10,000.00** which is non-refundable. The Bid documents can be purchased from Cashier, Phulbani Municipality. The bid document must be received from the office of Phulbani Municipality on payment of the required dues and the money receipt must be attached with the submitted bid document.
3. Bid documents consisting the schedule of quantities and the detail terms and condition of contract and other necessary documents can be seen in the bid documents.
4. Bids must be accompanied by the cost of bid security (EMD). Amount specified for the work in the Sl.02 payable at Phulbani and drawn/Pledged in favour of Executive Officer, Phulbani Municipality. Bid security (EMD) will have to in shape of Draft/FDR/TDR Form of Scheduled bank.
5. The bid documents will be available in Office of the Phulbani Municipality from **10.00AM** on dt **28.06.2022** up to **5.00PM** on dt **06.07.2022**

6. Bid shall be submitted in the office of the undersigned on or before 1.00 PM on dt.**07.07.2022** by Registered post/speed Post/Courier/by hand failing which the bid will be rejected.
7. Bids received shall be opened at 3.00PM on dt.**08.07.2022** in the office of the undersigned in the presence of the bidders who wish to attend. Only one person (participated bidder) or his/her authorised representative will be allowed to attend the bid opening. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. Any tenderer desirous to avail any facility as per certain circular/order of the Government, he/she has to apply for the same in original along with an affidavit the tender paper. However latest instructions/circular of the Government will be final in deciding the tender.
