NOTICE INVITING TENDER

- Sale of Tender paper :-** The tender documents will be available in the Official website <http://www.kandhamal.nic.in> from date **02.07.2022 to 25.07.2022** up to 5.00 P.M and can be downloaded from the website.
- The tenderer must pay non-refundable service charges/ paper cost as mentioned against the above works in shape of Bank draft from any nationalized bank payable to Balliguda drawn in favour of **Block Development Officer, Balliguda** or else the tender paper will be rejected.
- Bidders submitting downloaded bid documents from official website of NIC, Kandhamal (<http://www.kandhamal.nic.in>) are requested to deposit the requisite non-refundable fees as referred above in shape of demand draft prepared on or before last date of sale of tender paper and submit the same alongwith the bid keeping in a separate envelope marks cost of tender documents downloaded from the internet.

4. **Receipt of Tender Paper:** The tender paper will be received by registered post/ speed post only upto 5.00 P.M till **26.07.2022**. Sealed tender papers must be accompanied with attested copies of valid contractors licence, GST/VAT Clearance Certificate, PAN Card, No relation certificate, Non-refundable service charges and an affidavit regarding authenticity of the documents produced without which the tender paper is liable for rejection. The tenderer must write in capital letters, the name of the work i.e **'TENDER FOR THE WORK _____'** on the top corner of the envelope containing the tender documents.
5. The tender paper shall be opened by the Tender Committee in presence of the tenderers or their authorized agents on the scheduled date and time as mentioned below:

Date & time of opening of Tender paper: 27.07.2022 at 11.00 A.M

6. As regards to Bid security/ EMD, Govt. in Finance Department letter No. 8943/F, dtd. 18.3.2021 shall be followed. The tenderers/ bidders are required to submit Bid Security Declaration alongwith tender paper in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents.
7. Transfer or adjustment of EMD & ISD amount with other works will not be entertained.
8. The SC/ST bidders willing to avail the benefits allowed by Govt. to ST/SC candidates must furnish the Xerox copy of Caste certificate and an affidavit at the time of submission of tender documents.
9. The engineer bidders seeking exemption of EMD must submit their original licence at the time of opening of tender papers failing which the tender is liable for rejection.
10. The authority will not be responsible for any postal delay even if dispatched before due date.
11. As per Office Memo No. 4559/W, Dt. 5.4.2021 of Works Department, Govt. of Odisha, the following Additional Performance Security shall be fixed in case of abnormally low bids:

The successful bidder shall have to deposit the Additional Performance Security in shape of NSC/KVP/POTD/Deposit receipt of any schedule bank duly pledged in favour of **Block Development Officer, Balliguda** within seven days of receipt of letter/ intimation, failing which his/her bid documents shall be liable to be rejected/cancelled and EMD/ Bid security shall be forfeited.
