2. Up-to-date GST clearance, income tax return of last year i.e 2021-22 and copy of PAN card.
3. Photocopies/catalogues of Sample materials both in soft and hard copy are to be produced before the committee at the time of opening of tender/quotation for verification.
4. The rate should be quoted inclusive of all taxes GST, Entry Tax etc. as per Govt. guideline.
5. The rate is negotiable. No extra cost will be given for transportation of the forms. Supply is to be made at Circuit House, Phulbani.
6. The Quotation/tender will be summarily rejected if sample and above required documents are not produced.

The Quotation/tender received without fulfilling the above terms and conditions shall be treated as prima facie rejected and shall not be taken into consideration.
