The sealed quotations should reach the undersigned on or before **13.10.2022 at 4:00 P.M** and will be opened on **14.10.2022 at 11:00 A.M** in the office chamber of B.D.O, Tikabali in the presence of the bidders or their authorized representatives. **The quotations received without EMD and beyond the stipulated date and time and incomplete quotations in any respect shall not be taken into consideration and liable for rejection.** The B.D.O, Tikabali shall not be responsible for any postal delay. The quotations shall be accompanied with a bank draft worth of Rs.5000/- (Rupees five thousand) only towards Earnest Money Deposit drawn in favour of the B.D.O, Tikabali payable at SBI. The sealed quotations must be super scribe on the cover "**QUOTATION FOR VEHICLE BEARING NO. OR-12-3608 (Mahindra & Mahindra Jeep)**" and addressed to the B.D.O, Tikabali and also contain the complete address of the quotationers.

The quotation documents duly filled in enclosing a BD of Rs.5,000/- towards EMD must be submitted by the bidder through **Registered Post / Speed Post/Courier Service** only. The bank draft shall be subject to refund immediately except in case of the highest bidder whose offer is to be accepted.


**The intending persons may inspect the vehicle in the premises of B.D.O, Tikabali any working day during office hours after taking due permission from the B.D.O, Tikabali.**

The highest bidder whose quotation will be accepted shall deposit 25 % of the bid amount of the vehicle immediately after the same is confirmed and the rest amount within seven days from the date of acceptance of the quotation. **If he/she fails to deposit the bid amount within the stipulated period, the deposits including the earnest money shall be forfeited.** The vehicle shall not be delivered to the quotationer until after full payment and compliance with the requisite formalities. Tools, implements and spare parts will not be delivered to the bidder with the vehicle.

The successful bidder shall remove the vehicle from the premises of B.D.O, Tikabali within seven days from the date of deposit of the full amount of the bid money. Custody or safeguard of the vehicle shall be responsibility of the bidder and no claim or complaint on that account shall be entertained.


Apart from this, the successful bidder is required to deposit GST amount 18 % on the sale value in shape of the treasury challan and submit the original copy of the challan to the undersigned before release of the vehicle. On failure to remove the vehicle within the time as aforesaid, ground rent @ 1% of the bid money shall be charged for each day or part thereof till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, then the quotationer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle shall become absolute property of the B.D.O, Tikabali.
