TENDER CALL NOTICE

The Block Development Officer, Khajuripada, District-Kandhamal on behalf of Governor of Odisha invites sealed tender in single cover system for the construction of works as detailed in the table, from the class of eligible contacts as mentioned in column-5 (five) registered with state governments and Contractors of equivalent Grades/class registered with central Government / MES/ Railways to be eventually drawn up in PWD P-1 Agreement form, for execution of Buildings i.e. civil works. The proof of registration from the appropriate authority shall be enclosed along with the BID. If successful, the bidder who has not registered under state government has to register under state government has to register under the state PWD in the appropriate class of eligibility before signing of the agreement. The bidders may submit bids for the following work.

1. BID documents consisting of plans, specification the scheduled of quantities and the set of terms and condition of contract and other necessary document can be seen in the office of the undersigned during office hours every day except on Sunday and Public holidays till last date of sale and receipt of tender paper. The BID document will also be available in the district website, www.kandhamal.nic.in from date 28.10.2022 AT 10.00 AM to date 05.11.2022 up to 5:00Pm (in working days & working hours) at Panchayat Samiti, Khajuripada.

2. BID must be accompanied with EMD (Bid Security) of the amount Specified for the work in the table Col.6 above in the shape of NSC/POTD/Post office Saving pass Book/Deposit receipt/Bank Draft on any scheduled bank (valid minimum one year from the date of receipt) duly pledged in favour of Block Development Officer, Khajuripada, Kandhamal. Bidders desirous to hire as BID Security instead of 1% Bids without EMD or in other shape will not be considered and liable for rejection.

NB: MD in shape of case/pay order/Bankers cheques is not acceptable.

3. The sale of BID documents shall start from dt. 28.10.22 at 10:00 A.M. and close on date 05.11.22 at 5:00 P.M. during office hours in the office of the undersigned. BIDs shall be received by this office up to 5:00PM on date 05.11.22 through **registered post/ Speed post only**

Separate bid must be submitted for each individual work as mentioned in col.2.

4. The tender documents can also be downloaded also be downloaded from district website <http://Kandhamal.nic.in> on payment or tender cost as per column No.7 for each in shape of demand draft in favour of Block Development Officer, Khajuripada and submit the demand Draft and separate envelope marked : COST OF TENDER" DOWNLODED FROM INTERNET" along with the tender.

5. The Bid will be opened on dated 07.11.22 at 4:00 P.M in the Office of the undersigned in the presence of the members of the Block level tender/Purchas committee and bidders or their authorized representative. If the Office happens to be closed on the date of receipt/opening of the Bids as specified, above will be received/opened on the next working day of the same time and venue.

6. Bid document can be purchased from this office on payment of the tender cost mentioned against the work in Col.7 in shape of cash or Cheque drawn in favour of Block Development Office, Khajuripada payable at Khajuripada from any nationalized Scheduled Bank,GST. This is non-refundable.

7. Balance bid security @ 1% of contract value shall be pledge in parts in favour of Block Development Officer, Khajuripadacorresponding to the respective value of works and deposited during drawl of agreement.

8. Bidders shall submit original affidavit regarding authenticity of their documents and E.M.D along with their Bids shall be accompanied with attested true copy of valid registration certificate, valid GST clearance certificate and PAN card, IT return of last three years otherwise he/her bids shall be declared a non-responsive and thus liable for rejection. The Original certificates of the two lowest bidders are to be produced before Assistant Executive Engineer/ Block Development Officer, Khajuripada for verification.

9. Other details can be seen in the bidding documents.

10. Checklist is to be duly filled in.

11. Engineer contractors desirous to avail facility of exemption of E.M.D is required to submit as affidavit to the affect that he has not yet availed the facility for more than one works during current financial year. The name of the work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.


12. The ST.SC contractor desires to avail price preference is required to submit affidavit.

13. The name of the work for which and authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
14. Additional performance security shall be deposited by the successful bidders when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10%. In such an event the successful bidders will have to deposit the additional performance security to the extent of the differential cost of the bid amount in shape of POSB/NSC/POTD/Deposit receipt of scheduled bank pledged in favour of Block Development Officer, Khajuripada.
15. If previously the bidders got any tender work in this Panchayat Samiti and the work is not completed and declared as defaulter than the bidders is not eligible to bid for any tender work.
16. Any corrigendum/ Addendum will be displayed in the website <http://Kandhamal.nic.in> only.
17. Conditional tender will summarily be rejected.
18. The items covered in clause No-147 of DTCN are required as ESSENTIAL CRITERIA for eligible for qualification.
