### TENDER CALL NOTICE

The Block Development Officer, Khajuripada, District-Kandhamal on behalf of Governor of Odisha invites sealed tender in single cover system for the construction of works as detailed in the table, from the class of eligible contractor as mentioned in column-7 (seven) registered with state governments and Contractors of equivalent Grades/class registered with central Government / MES/ Railways to be eventually drawn up in PWD P-1 Agreement form, for execution of Buildings i.e. civil works. The proof of registration from the appropriate authority shall be enclosed along with the BID. If successful, the lowest quoted bidder has to make agreement with Block Development Officer, Khajuripada in appropriate form following due procedure.


#### Term and Condition

- BID documents consisting of plans, specification, the scheduled of quantities and the set of terms and condition of contract and other necessary document can be seen in the office of the undersigned during office hours every day except on Sunday and Public holidays till last date of sale and receipt of tender paper. The BID document will also be available in the district website; [www.kandhamal.nic.in](http://www.kandhamal.nic.in) from date 21.11.2022 to 30.11.2022 (in working days & working hours) at Panchayat Samiti, Khajuripada.
- Bidders are required to submit a "BID SECURITY DECLARATION" along with their the bid as per the Office Memorandum No. 4710 Dtd. 12.04.2022 of Works Department Govt. of Odisha in Lieu of EMD, failing which the bid is liable for rejection.

3. The sale of BID documents shall start from dt. 21-11-2022, and close on date 30-11-22 during office hours in the office of the undersigned. BIDs shall be received by this office up to **5:00PM on date 30-11-2022** through **registered post/ Speed post** only. Bids received in any other mode shall not be taken in to consideration. Incase of Delay in delivery of bid the undersigned shall not be responsible and liable for rejection.
4. Separate bid must be submitted for each individual work as mentioned in col.2.
5. The tender documents can also be downloaded from district website <http://Kandhamal.nic.in> on payment or tender cost as per column No.7 for each in shape of demand draft in favour of Block Development Officer, Khajuripada and submit the demand Draft in separate envelope marked : COST OF TENDER" DOWNLOADED FROM INTERNET" along with the Bid.
6. The Bid will be opened on dated 01-12-2022 at 11.00 AM in the Office of the undersigned in the presence of the members of the Block level tender committee and bidders or their authorized representative who wish to attend. If the Office happens to be closed on the date of receipt/opening of the Bids as specified, above will be received/opened on the next working day of the same time and venue.
7. Bid document can be purchased from this office on payment of the tender cost mentioned against the work in Col.6 in shape of cash or Cheque drawn in favour of Block Development Officer, Khajuripada payable at Khajuripada from any Scheduled Bank. This is non-refundable.
8. The EMD relaxation in view of Covid-19 pandemic situation as notified by Govt. of Odisha shall be enforced.
9. Bidders shall submit original affidavit regarding authenticity of their documents enclosed, along with their Bids shall be accompanied with attested true copy of valid registration certificate, valid GST clearance certificate and PAN card, IT return of last three years otherwise he/her bids shall be declared a non-responsive and thus liable for rejection. The Original certificates of the two lowest bidders are to be produced before Assistant Executive Engineer/ Block Development Officer, Khajuripada for verification.
10. Other details can be seen in the bidding documents.
11. Checklist is to be duly filled in.
12. Engineer contractors desirous to avail facility of exemption is required to submit as affidavit to the affect that he has not yet availed the facility for more than one works during current financial year. The name of the work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.
13. The ST/SC contractor desires to avail relaxation is required to submit affidavit along with their Caste Certificate.
14. The name of the work for which and authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
15. If previously the bidder got any tender work in this Panchayat Samiti and the work is not completed and declared as defaulter then the bidders is not eligible to bid for any tender work.
16. Any corrigendum/ Addendum will be displayed in the website <http://Kandhamal.nic.in> only.
17. Conditional tender will summarily be rejected.
18. The items covered in clause No-147 of DTCN are required as ESSENTIAL CRITERIA for eligible for qualification.
