
- 1. Sale of Tender paper:-** The tender documents will be available in the Official website <http://www.kandhamal.nic.in> from date **19.11.2022 to 12.12.2022** up to 5.00 P.M and can be downloaded from the website. In case any tenderer fails to download the tender paper, he/she may contact the Office of BDO, Tumudibandha for softcopy during office hours from 19.11.2022 to 12.12.2022 during office hours on payment of Rs 200/- CD
- 2.** The tenderer must pay non-refundable service charges as mentioned against the above works in shape of **Bank draft** from any nationalized Bank payable to Tumudibandha drawn in favour of **BDO, Tumudibandha** or else the tender paper will be rejected.
- 3.** Bidders submitting downloaded bid documents from official website of NIC, Kandhamal (<http://www.kandhamal.nic.in>) are requested to deposit the

requisite non-refundable fees of **Rs 10000/-** for sl 1 , 2 and **Rs 6000/-** for sl 3,4,5 & 6 in shape of demand draft prepared on or before last date of sale of tender paper and submit the same along with the bid keeping in a separate envelope marks cost of tender documents downloaded from the internet.

4. **Receipt of Tender Paper:** The tender paper will be received by registered post/speed post only upto 3.00P.M till **14.12.2022**. Sealed tender papers must be accompanied with self attested copies of valid contractors license, GST Certificate , PAN Card, No relation certificate, Non-refundable service charges ,Valid labor license and an affidavit regarding authenticity of the documents produced without which the tender paper is liable for rejection. The tenderer must write in capital letters (TENDER PAPER) on the right site top corner of the envelope containing the tender documents.
5. No EMD is required as per Office memorandum No.5984 dated 27.4.2021 of works department, Government of Odisha. Instead the bidders are to submit a "Bid Security Declaration" in shape of an affidavit that if they withdraw or modify their bids during period of validity etc, they will be suspended for the time specified in the tender documents.
6. The tender paper shall be opened by the BDO, Tumudibandha/ his authorized officer in presence of the tenderers or their authorized agents on the scheduled date and time as mentioned below:  
**Date & time opening of Tender paper: 15.12.2022 at 11.00 A.M**
7. Transfer or adjustment of EMD & ISD amount with other works will not be entertained.
8. The SC/ST bidders willing to avail the benefits allowed by Govt. to ST/SC candidates must furnish the Xerox copy of caste certificate and an affidavit at the time of submission of tender documents.
9. The engineer bidders seeking exemption of EMD must submit their original license at the time of opening of tender papers failing which the tender is liable for rejection.
10. The authority will not be responsible for any postal delay even if dispatched before due date.
11. The successful bidder quoting less than the amount put to tender has to deposit the differential amount (as stated below) in shape of NSC/KVP/POTD/ Deposit receipt of any schedule bank duly pledged in favour of BDO, Tumudibandha, at the time of agreement,
