The BDO G.UDAYAGIRI on behalf of Governor of Odisha invites **Percentage Rate** bids in single cover system for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways, to be eventually drawn up in PWD P-1 **Agreement** form, for execution of Buildings i.e. **civil works**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement. The bidders may submit bids for the following work.

1. Bid documents consisting of plans, specification, the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the office of the undersigned during office hours every day except on Sunday & Public holidays till last date of sale and receipt of tender paper. The Bid documents will also be available in the district website <http://Kandhamal.nic.in> from 24.11.2022, 11.00 AM to 14.12.2022, 3.00 PM.

2. The sale of the Bid document shall start from Dt. 25.11.2022 at 11.00 AM and close on Dt. 14.12.2022 at 3.00 P.M. During office hours in the office of the under signed. The tender documents should be delivered along with the relevant documents of one work in the sealed cover with caption the name of the work over the envelope. Bids shall be received through Registered Post/ Speed Post with AD, on or before Dt. 14.12.2022 at 3.00 P.M. The authority will not be held responsible for any Postal delay in delivery of the Bid documents or non-receipt of the same.
3. The Bid will be opened on Dt. 15.12. 2022 at 11.00 A.M. in the office of the undersigned in the presence of the members of the Block Level Tender/Purchase Committee and the bidders or their authorised representative. If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue.
4. Bid documents can be Obtained from this Agency on payment of the tender cost mentioned against the work in Col. 6 in shape of cash or DD drawn in favor of BDO G.Udayagiri. Payable at G.Udayagiri from any Nationalized scheduled Bank towards cost of tender paper. This is non-refundable.
5. The tender documents can be downloaded from district website <http://kandhamal.nic.in> on payment of tender cost of Rs 6000/- (Rupees Six thousand each set in shape of Demand Draft in favour of BDO G.Udayagiri. and submit the Demand Draft in a separate envelope marked "COST OF TENDER DOCUMENT DOWNLOADED FROM INTERNET" along with the tender..
6. Bidders shall submit original affidavit regarding authenticity of their documents with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, valid GST clearance certificate and PAN card, valid labor license and list of machineries and T&P otherwise his/her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest three bidders are to be produced before Additional PD(Tech.), Zilla Parishad, Phulabani for verification.
7. Bid security @2% contract value shall be pledged in parts in favour of BDO G.Udayagiri corresponding to the respective value of works and to be deposited at the time of agreement.
8. Other details can be seen in the bidding documents.
9. Checklist is to be duly filled in.
10. Engineer Contractors desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.
11. The ST/SC contractor desires to avail price preference are required to submit an affidavit.
12. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.
13. If the rate quoted by the bidder is less then 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest BIDs. But if more than one bid is quoted at 14.99% less than the estimated cost, the tender accepting authority will finalized the tender through a transparent lottery system.
14. The Successful bidder quoting less than the amount put to tender has to deposit the differential amount (as stated below) in shape of post office saving bank account/ NSC/ KVP/ Post office TDR/

Deposit receipt of scheduled bank. duly pledged in favour of the BDO G.Udayagiri, Kandhamal, within seven days of issue of letter of Acceptance (LOA) by the BDO G.Udayagiri at the time of agreement.

17. Conditional tender will summarily be rejected.
18. Building and other Construction Workers Welfare Cess @ 1% (One Percentage) of the cost of construction shall be deducted from bills.
19. Rate shall be putted in percentage both in figure and word writing excess or less into one decimal point shall be considered infect round off.
20. The items covered in Clause No- 147 of DTCN are required as essential criteria for eligibility for qualification.
21. **The authority reserves right to reject any or all the bids without assigning any reason thereof**
