**SHORT TENDER CALL NOTICE FOR HIRING OF VEHICLE**

Sealed Quotations /Tenders are invited from intending firms/ reputed Travel Agencies/Tour operators/ Private individuals for providing one No. of TUV300/Bolero/SumoGold/Ertiga or Tiago/Bolt/Celerio/Dezire(Petrol) vehicle sitting capacity not more than eight including Driver which shall confirm to the terms and conditions (Annexure-I) for official use in the office of the A.R.C.S. , Phulbani on monthly hire basis.

- 1.The vehicle must be in Road worthy condition and shall not be more than (3) three years older from the date of initial registration and must have valid registration certificate, Insurance certificate, fitness certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying the vehicle.
- 2.The Driver of the vehicle must have valid license for driving light transport passenger vehicle and should be sufficient experienced in driving transport passenger vehicle.
- 3.The driver should be well behaved, gentle and obedient in nature.
- 4.A sum of Rs.5000/-(Rupees five thousand) only shall be deposited by the intending bidders in shape of account Payee Bank draft drawn in favour of the A.R.C.S., Phulbani and submitted along with the tender as security deposit . After completion of tender process the amount will be refunded to unsuccessful bidders.
- 5.(i) The monthly rate of hire charges is maximum up to 31000/- p.m. and fuel charges extra ( for TUV300/Bolero/SumoGold/Ertiga)  
(ii) The monthly rate of hire charges is maximum up to 20000/- p.m. and fuel charges extra ( for Tiago/Bolt/Celerio/Dezire etc.)
- 6.(i)The vehicle must achieve a fuel efficiencies of 10 Kms. Per liter as the minimum. ( for TUV300/Bolero/SumoGold/Ertiga)  
(ii) The vehicle must achieve a fuel efficiencies of 17 Kms. Per liter as the minimum. ( for Tiago/Bolt/Celerio/Dezire etc.)
7. The detail of the make and year of manufacture of the vehicle, registration number mileage (Kms covered per liter) and name of the Driver with Driving license No. and period of validity should be specifically provided in the general bid information brochure to be furnished with the Quotation/Tender (Annexure-III).



10. The authority reserves the right to accept/reject/negotiate any or all part of the tender without assigning any reasons thereof..






