TERMS & CONDITIONS

1. The proposal should be properly sealed super scribed as *Expression of Interest for Execution of "Repairing & maintenance of the ACs of DHH, Phulbani"*.

Supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by Notary Public in a non judicial stamp paper of Rs. 20/- (as per Annexure- A)
3. The Firm should have valid GST, registered Firm, and Xerox copy must be submitted the proposal.
4. Xerox copy of organization PAN.
5. The lowest bidders proposal shall be accepted.
6. The authority reserves full rights to accept or reject any or all proposals without assigning any reason thereof.
7. The firm or agency must be complete the required maintenance work within 7 days receipt of the work order.
8. The rate must be quoted including all taxes.


