## **2. Bid Price**

- a) The transportation charges also to be included in the Bid Price.
- b) All duties, taxes and other levies payable by the dealer under the contract shall be included in the total Price.
- c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The prices should be quoted in Indian Rupees Only.
- e) Prices quoted should be inclusive of installation charges.

## **4. Validity of Quotations**

Quotations shall remain valid for a period not less than 60 days after the dead line date specified for submission.

## **5. Evaluation of Quotations**

The purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- a. are properly signed and
- b. Confirm to the terms and conditions, and specifications.

The Quotations would be evaluated for the entire item together.

## **6. Award of contract**

- a. The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- b. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

**7.** Payment shall be made after delivery & installation of the goods through A/C Payee cheque / R.T.G.S. after submission of the bills and vouchers.

**8.** Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

**9.** Any legal dispute arising out of this is subject to concerned district jurisdiction only.

**10.** Notwithstanding the above, the Collector, Kandhamal reserves the right to accept or reject any quotation, alter scope of work and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter. The bidders may be present in person or through one of their representatives(s) during the opening of quotations as per the date and time fixed by the Collector, Kandhamal.

**11.** A Sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank draft drawn in favour of the Collector, Kandhamal Payable at SBI, Kandhamal and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.


