





- 2 The bidder shall transfer online the cost of bid document, Earnest Money deposit/Bid Security of the amount specified for the work in the table col.5 & 6 above as part of its bid through a process as mentioned under DTCN.
- 3 **Tender Paper cost & EMD:** The cost of Tender Paper as indicated above shall be received online along with the bids as per guideline issued by Works Deptt. and the EMD for each work is not required. The procedure of bid submission using electronic payment of Tender Paper Cost and EMD by the bidder may be referred in Works Deptt. O.M. No. 17254, Dt. 05.12.2017 & Works Deptt. O.M No.- 4710/W Dt.12.04.2022 which have been added to the DTCN. Tenderers desiring to hire machineries or equipment's from outside the state has to furnish 2% of the amount put to tender as bid security.
- 4 The Bid documents will be available in the website: <http://tendersodisha.gov.in> from **10.00 AM of 06.06.2023** to **19.06.2023** for online bidding. Any addendum / corrigendum / cancellation of tender if any will be hosted in the website only can also be seen in the said website.
- 5 The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- 6 Bids shall be received only on "on line" on or before **5.00PM of 19.06.2023**.
- 7 Bids received on line shall be opened at **11.30 Hours on 21.06.2023** in the office of the Project Administrator, ITDA, Phulbani in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 8 Other details can be seen in the bidding documents.
- 9 The Bid documents consisting of Plans , Specifications, the schedule of Quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: www.tendersodisha.gov.in
- 10 The bidders shall have to upload the Contractor license, PAN, GSTIN and other documents as per DTCN during participation in the bid. Failing of which the bid will be summarily rejected.

Amendment to Appendix – IX, Clause – 36 of OPWD Code Vol.-II by inclusion. If the rate quoted by the bidder is exactly 15% less or more than 15% less of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representatives and Asst. Executive Engineer will remain present.

- 12 Additional Performance Security (As per Works Department OM No.4559 dt.05.04.2021) shall be obtained from the bidder when the bid amount is less than estimated cost put to the tender. In such an event only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security as per the following rate. Sl. No. Range of Difference between the estimated cost put to tender and Bid amount Additional Performance Security to be deposited by the Successful bidder. i. Below 5% No Additional Performance Security ii. From 5% and above and below 10% 50% (Difference between estimated cost put to tender and Bid Amount) iii. From 10% and above 150% of (Difference between estimated cost put to tender and Bid Amount) The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of term Deposit Receipt pledged in favour of Project Administrator, ITDA, Phulbani / Bank Guarantee in favour of the Project Administrator, ITDA, Phulbani from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Phulbani within seven days of issue of Letter of Acceptance (LOA) by the Project Administrator, ITDA, Phulbani (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further, proceeding for blacklisting shall be initiated against the bidder. (Vide Office Memorandum No.14459/W dated 20.09.2018 of Works Department, Govt. of Odisha).
- 13 The bidder has to submit the Cost of Tender Paper as the amount specified for the work electronically as per Works Department Memo No. 17254, dt. 05.12.2017. At the time of online bid submission EMD not required as per Works Deptt. O.M No.- 4710/W Dt.12.04.2022 due to the Pandemic. But the cost of EMD must be submitted the successful bidder at the time of Drawl of Agreement as per Works Department Memo No. 17254, Dt. 05.12.2017.
- 14 DTCN signed, Affidavit of Authenticity of documents, Bid Security Declaration, GSTIN Registration Certificate, PAN Card, valid Contractor Data Base Management System (CDMS) Registration Certificate & other documents as mentioned in the DTCN must be clear visible Scanned and uploaded in .pdf format in the web-site along with the bid.
- 15 The SC / ST / Engineering and other eligible contractors who claims price preference shall have to submit application/affidavit and upload the documents in the portal.
- 16 Any addendum / corrigendum / cancellation of above tender will be published in the web-site www.tendersodisha.gov.in and in the office notice board.
- 17 The authority reserves the right to cancel any or all bids without assigning any reason.
