Sealed quotations are invited from among the intending authorized dealers or firms having the authorized GST registration, Income Tax clearance to supply of tissue culture strawberry saplings (variety-winter dawn), Apple Beer (Variety Thai Ball Sundari, Miss India, Taiwan Fresh, Kashmir Sundari (Red/Green)), Colored Capsicum (Variety Hybrid Red/Yellow), Blue Berry (High Bush Plant of varieties like Blue Crop, Blue Ray, Heartbeat(1-2 yr plant, stem length 25-45cm), Cherry (Red Cherry Grafted plant, Lownbert Mishri Cherry of Kashmir sweet cherry(Lapins –Hybrid, self pollinated), Pears (Varieties of Punjab Gold,Punjab Nectar, Punjab Beauty), Grapes (Variety of Thompson Seedless, Bangaluru Blue, sharad seedless), Guava (Variety VNR/Allahabad Safedā/Lucknow-49), Pineapple (Variety Queen) and Moringa (Variety PKM-1, PKM-2,Wingless,ODC-3) in phase manner including loading, unloading and transportation cost, specification of items, terms and conditions made for participation can be downloaded in the website i.e www.kandhamal.nic.in. 1. The lowest Bidder will supply the required saplings during this financial year 2023-24.
2. The bidder can submit only one bid. Multiple bids submitted by any bidder may result in rejection of all his bids.
3. The Bidder must have registered under Goods & Services Tax (GST) and must have a valid GSTIN number & PAN (Permanent Account Number).
4. Turnover of the firm must be minimum 50 Lakh in last three financial year.
5. The bidders selected have to supply the items within 15days from the date of issuance of work order.
6. The bidder whose bid is accepted, will be awarded the contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

7. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.


