1. Sealed tender in the prescribed form to be eventually drawn-up in PWD Form P-1 (percentage Rate bids) in conformity with detailed Tender call notice is invited by the Block Development Officer, DARINGBADI on behalf of Government of Odisha for construction of Building work/CD work as detailed in the table below from "D" Class / "C" Class Contractors registered with the State Government and contractor of equivalent grade/ Class registered with Central Government/ MES/ Railways having registration for Civil and Electrical Works or contractors having registration for Civil Works only.
2. The bidders may submit bid for the following works.

3. Bid documents consisting of plans, specification, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen and downloaded in the website [www.kandhamal.nic.in](http://www.kandhamal.nic.in)
4. Bids must be accompanied by earnest money deposit/ bid security of the amount specified for the work in the table column No.05 above, pledged in favour of Block Development Officer, Daringbadi as specified for the work at column No.03 above and will have to be in any one of the forms as specified in the bidding documents.
5. The bid documents will be available in the website [www.kandhamal.nic.in](http://www.kandhamal.nic.in) from 10:00 AM of Dt.13.06.2018 to 1:00 PM of Dt.28.06.2018.
6. Bid documents shall be dropped in the Tender Box placed in the Office Chamber of Block Development Officer, Daringbadi on or before 1:00 PM of Dt.28.06.2018.
7. Bids received shall be opened at 4:00 PM of Dt.28.06.2018 in the office of the Panchayat Samiti, Daringbadi in the presence of the bidders or their authorized representatives. The documents submitted must be produced in original by the bidders or their representatives before opening of the bids. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day as per the scheduled time, date and venue.
8. If the bidders or his representatives fails to produce the original documents, EMD in shape of NSC/TDR/KVP/Fixed Deposit receipt of nationalized bank/Postal deposit (**as per table column No.05**) and the cost of Tender Papers in shape of Demand Draft (**as per table column No.06**) his bid shall not be taken into consideration.
9. The cost of bid documents shall be deposited in shape of Demand Draft of any nationalized scheduled bank duly pledged in favour of Block Development Officer, Daringbadi (**as per table column No.06**).
10. Other details can be seen in the bidding documents.
11. Bidders shall submit original affidavit regarding authenticity of their documents and EMD alongwith their bids shall be accompanied with attested true copy of valid registration certificate, valid GST clearance certificate and PAN card, otherwise his/her bids shall be declared a non-responsive and thus liable for rejection.
12. The ST/SC contractors desire to avail price preference is required to submit an affidavit.
13. If more than one bidder quotes equal percentage then lottery will be drawn among them for selection of bidder.
14. Defaulter contractors of Panchayat Samiti, Daringbadi are not allowed to consider at the time of finalization of tender process.

16. Conditional tender will summarily be rejected.
