TENDER CALL NOTICE

No. 858, Date: 01.07.2018

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing one numbers of Bolero Diesel Non A/c driven vehicles having setting capacity not more than ten including driver, which shall conform to the Terms and conditions (Annexure-II) for official use in Dist. Social Security Officer, Kandhamal, Phulbani, Department of Social Security & Empowerment of Persons with Disabilities on monthly rent basis:

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the DSSO, Kandhamal and submitted along with the tender EMD as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants) as per finance Deptt. Letter No.27037 dt.8.10.2015 the maximum hire charges per month excluding diesel cost Rs.20000-00 for District (service tax would be reimbursed separately over and above the hire charges).
- 6) The Vehicle must achieve a fuel efficiency of 10 Kms per litre.
- 7) The details of the make and year of manufacture of the vehicle, registration number, mileage(Kms covered per litre) and name of the Driver with Driving License number and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender(Annexure-III)

- 8) The Quotation completed in all respect should reach the undersigned on or before Dt.11.7.2018 by 4.00 PM and shall be opened on the day 12.07.2018 at 11.00 AM in presence of the bidder or authorised representatives.
- 9) The application form of quotation/tender containing General Bid information & Terms and conditions for Hiring of Vehicle etc. will be available with DSSO, Office on payment of Rs.100/- from 04.07.2018 to 11.07.2018 or can be downloaded from (www.kandhamal.nic.in) from Dt. 04.07.2018 to 11.07.2018 in case the application form is downloaded from website the applicant shall furnish a Demand draft for an amount of Rs.100/-(Rupees One hundred) only towards the cost of application along with the application.
