
QUOTATION CALL NOTICE

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing one number of Indica Diesel vehicles having sitting capacity not more than five including driver which shall confirm to the terms and conditions (Annexure-I) for official use in District Panchayat Officer, Kandhamal, Phulbani on monthly rent basis.

1. The sealed quotations/tenders should reach the District Panchayat Officer, Kandhamal **on or before 25/07/2018 at 11.00 A.M and will be opened on the same day at 4.30 P.M in the office chamber of P.D., DRDA, Kandhamal** in the presence of the bidders or their authorized representatives. If this day is declared later as Government holiday, the quotations/tenders will be received and opened on the next working day as per the scheduled time.
2. The quotations/tenders received beyond the stipulated date and time and incomplete quotations in any respect shall not be taken into consideration and liable for rejection. The District Panchayat Office shall not be responsible for any postal delay.
3. The quotation/tender documents completed in all respect must be submitted by the bidder **by person/Registered Post/Speed Post/Courier Service addressed to the District Panchayat Officer Kandhamal, Phulbani-762001.**
4. The vehicle must be in Road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle.
5. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.

6. The Driver should be well behaved, gentle and obedient in nature.
7. A sum of **Rs.5000/-** shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the District Panchayat Officer, Kandhamal payable at SBI, Main Branch, Phulbani and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
8. The monthly rate of hire charge should be quoted separately in the General Bid Information (excluding fuel and lubricants)
9. The Vehicle must achieve a fuel efficiency of 17 Kms. per litre.
10. The details of the make and year of manufacture of the vehicle, registration no. , mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the General Bid Information to be furnished with the Quotation (Annexure-III)
11. The application form of quotation/tender containing General Bid Information & Terms and conditions for Hiring of Vehicle etc. will be available in the District Panchayat Officer, Kandhamal on payment of Rs.100.00(Rupees One Hundred)only by a demand draft towards the cost of the application form from **10.00 A.M to 5.00 P.M (in office hours expect holidays)** from date 09/07/2018 to 24/07/2018 .
12. In the event of similar price offered by more than one vehicle owner, the selection will be made through draw from lot.




