EXPRESSION OF INTEREST

Expression of interest proposals are invited from the wholesaler/distributor/retailer towards supply of the drugs and Medical consumables on discount basis for the RSBY/BKKY & other beneficiaries to the DHH, Phulbani.

The proposal should reach the office of the undersigned on or before **07.08.2018 by 03.00 PM** and the same will be opened on the same day **at 04.00 PM** in the office of the Chief District Medical and Public Health Officer, Kandhamal in the presence of the firms or their authorized representatives.

TERMS & CONDITIONS

1. The proposal should be properly sealed super scribed as *"Expression of Interest for the supply of drugs & Medical Consumables on discount basis to the DHH, Phulbani"*.
2. Supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a Notary Public (as per Annexure - A).
3. The Firm should have valid GST, registered Firm, and Xerox copy must be submitted with the proposal.
4. Xerox Copy of organization PAN.
5. Xerox copy of valid Drug License from the competent authority must be submitted with the proposal.
6. The highest discount proposal shall be accepted (Discount should not be less than 10 %)
7. The local Firm i.e. within 200 mts radius from District Headquarter Hospital, Phulbani shall be given preference Annexure - C.
8. The required item should be supplied immediately to the patients & less MRP medicines shall be preferred.
9. The approved discount of the firm shall remain valid up to one year from the approval date and MOU should be signed with the undersigned before execution of purchase.
10. The authority reserves full rights to accept or reject any or all proposals without assigning any reason thereof.
11. The approved firm should be able to supply the required medicines on 24x7 basis to meet any emergency situation. They must submit the undertaking that the medicine shop must be opened on 24x7 basis (Annexure – B).
12. The purchase may be in bulk quantity or may be single quantity.
13. The purchase shall be made on credit basis and the payment shall be made as early as possible through cheque/online.
