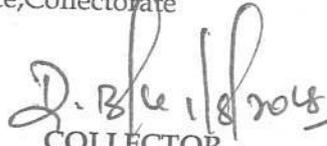

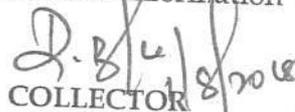

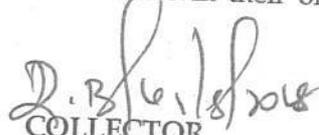

TERMS AND CONDITIONS:

1. EMD : Rs 25,000/- (Rupees Twenty five thousand) only is to be deposited along with the Tender in shape of Demand Draft in favour of District Welfare Officer, Kandhamal Drawn on any nationalized bank payable at Phulbani (amount refundable without interest). The EMD money shall be forfeited in the event of withdrawal of the tender once submitted or in the case of successful bidder who failed to execute necessary agreement within the specified period.
2. Sample : The tenderer are required to submit the samples of the items quoted for verification by the Committee Members at the time of opening of Tenders. The samples of approved items will be retained in this office till completion of the agreement. Quality of the utensils will be given priority.
3. Security Deposite : The successful bidder has to deposite 5% of the value of supply order (refundable without interest) in shape of a Demand Draft in favour of District Welfare Officer, Kandhamal Drawn on any nationalized bank payable at Phulbani at the time of agreement before issuing supply order. The Security Deposite shall be forfeited in case any term and conditions of the contract are infringed or the bidder fails to make complete supply satisfactorily and timely.
4. Delivery of Items : The successful Tenders will have to supply the items as per the approved specification are indented within 15 days of receipt of Supply Order failing which the security deposite will be forfeited. Delivery of utensils shall be made at School point.
5. Place, date and time of receiving Tender : The sealed tender papers should reach the District Welfare Officer, Kandhamal through Registered Post/ Speed Post only during office hours on or before 18.8.18. The authority will not be responsible for any postal delay.
6. Place, Date and time of opening of tender : The tender papers will be opened at **D.W.O. Office, Collectorate, Kandhamal** on 21.8.18 at **11.00 a.m.** in the presence of the bidders or authorized representative and the member of the District Purchase Committee, Kandhamal.
7. Certificateto be furnished along with the tender : The tenderer should accompany a copy of valid VAT-612 clearance certificate, PAN card, GST certificate, IT return for 3 years i.e (2015-16,2016-17 & 2017-18) registration certificate for dealers lible to pay value added tax, (UAM)Udyog Adhar Memorandum with production certificate failing which the Tender paper will be liable for rejection .
8. Signing of Agreement : The successful bidders to sign an agreement in non-judicial stamped paper worth of Rs 10/- with the undersigned within 02 days after finalization of the tender .

No extra amount over and above the rates approved by the District Purchase Committee will be paid. The utensils will be verified randomly by District Level Committee Members.

Only one quotation should be submitted by one party. No preference will be given to any bidder or class of bidder either for price or for any other reason.

Condition /incomplete Tenders are liable for rejection.

The Tenders received without fulfilling the Terms and Condition are liable for rejection.

The Collector, Kandhamal reserves the right to accept or reject any or all tenders, full or part of the tenders without assigning any reason what-so-ever and no intimation will be given to the bidders. In this account no disputes will be entertained. Any disputes arises subject to Phulbani Jurisdiction only.
