

In pursuance of letter no. 3190 dtd. 17.07.2018 and office order dated 16.08.2018 of Sub-Collector, Balliguda Third time invited Sealed quotation/Tenders from interested reputed Travel Agencies/Tour operators or private individuals for providing one numbers of Bolero/Tata Sumo(Non A/C) for the Office of the Child Development Project Officer, K.Nuagaon on monthly hire basis for the period of one year during the FY- 2018-19 on the following terms and conditions.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old for the date of initial registration and must have valid registration certificate, insurance, Fitness Certificate, Valid Contract carriage permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
2. The Driver of the vehicle must have a valid Driving License for light transport passenger vehicle and should be sufficiently experienced in driving and he should be posses well behaved, gentle and obedient in nature.
3. A sum of Rs. 5,000/-Rupees(Five thousand)only shall be deposited by the intending bidders in shape of Account Payee SBI Bank Draft in favour of Child Development Officer, K.Nuagaon as EMD on security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidder.
4. The maintenance charges including repair/replacement of spare parts remuneration of the driver etc. shall be borne by the vehicle owner.
5. The bidder is required to mention clearly per KM per one liter of fuel.
6. The monthly rate of hire charge be quoted separately in the general bid information (including fuel and lubricants) as per Govt. in WCD and Mission Shakti Deptt. letter No. 10449/wcdms dtd. 23.06.2018 and letter no. 27037 dtd. 08.10.2015, the maximum hire charges including fuel Rs. 20,833/- Rupees (Twenty thousand eight hundred thirty three)only per month will be paid on completion of vehicle log book as well as on receipt of funds from government and drawl from treasury.(service tax would be reimbursed separately over and above the hire charges).

The tender paper should addressed to the CDPO K.Nuagaon and written on the top of the cover as "Application form for Hire vehicle" in capital letter with full bidder address will be received by the undersigned on or before 23.08.2018 by 5.00 PM and shall be opened by the Sub-Collector, Balliguda on 24.08.2018 at 11.00 am in presence of the bidder or their authorized agent at Sub-Collectorate, Balliguda.


