3. The tender papers shall have to be submitted in a sealed cover for each work separately through Registered post / Speed Post in the addressed of Block Development Officer, Chakapad and he should mention 'TENDER PAPER FOR PANCHAYAT SAMITI WORK' only without mentioning the name of the work in the top of the cover.

4. The tender paper should accompany attested Xerox copies of valid Registered License, up-to-date Income Tax Clearance Certificate, GSTIN , PAN Card and also an affidavit mentioning the authenticity of the documents submitted.
5. SC/ST contractors should submit attested Xerox copy of Caste certificate and an undertaking in shape of affidavit that he has not availed the concession more than three times in the current financial year and he should produce the original caste certificate and original license for verification at the time of opening of tender paper.
6. The EMD to be deposited should be duly pledged in favour of the Block Development Officer, Chakapad in shape of NSC/KVP/POTD or in shape of Bank Draft/Banker Cheque pledged in favour of the Block Development Officer, Chakapad payable at Chakapad along with the tender documents.
7. Engineer Contractors seeking exemption of EMD should produce the Original contract license before the tender opening authority for verification and he should submit an affidavit to the effect that he has not been awarded with more than three works without EMD in the current financial year .
8. Transfer or adjustment of EMD/Differential amount/Initial Security Deposit (ISD) will not be entertained.
9. Additional performance security shall be deposited by the successful bidder when the bid amount is seriously unbalanced i.e. less than the tendered amount by more than 10%. In such an event the successful bidder will deposit the additional performance security to the extent of the differential cost of the bid amount and 90% of the tender amount in shape of Bank Draft/Banker Cheque drawn in favour of the Block Development Officer, Chakapad payable at Chakapad at the time of agreement.
10. The sealed tender paper can also be sent of the undersigned through Registered Post/Speed Post only.
11. The authority shall not be held responsible for any postal delay.
12. The authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
