


Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing one number of Bolero Diesel (Non A/c.) driven vehicle having sitting capacity not more than ten including driver, which shall confirm to the terms and conditions contained at **Annexure-II** for official use in I.C.D.S. Project, Daringbadi on monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than 5 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the C.D.P.O., Daringbadi, and submitted along with the tender EMD as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The Hiring of the vehicle may be undertaken at the rate of Rs..2.50 Lkh per Year, monthly rate of hire charge be quoted separately in the general bid information (including fuel and lubricants) as per Govt. in W. C.D. and Mission Shakti Deptt. Letter No. 10449/WCDMS dated 23-06-2018 Letter No.27037 dt.8.10.2015 & L.No. WCD-ICDS-VEH-0001-2015 5762/ WCDMS, Dt: 04/04/2018 of Govt. Of Odisha Department of Women & Child Development and Mission Shakti the maximum hire charges including diesel cost, Approximately Rs.**20,833/- (Rupees twenty thousand eight hundred thirty three) only** per month which is the maximum ceiling. No expenditure beyond the ceiling is permissible) for ICDS Project (service tax would be reimbursed separately over and above the hire charges).
6. The Vehicle must achieve a fuel efficiency of 10 Kms. per litre.

The details of the make and year of manufacture of the Vehicle, Registration number, mileage (Kms covered per litre) and name of the Diver with Driving License number and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender paper at **(Annexure-III)**
