**TERMS AND CONDITIONS:**

01. The vehicle must be in Road worthy condition preferably shall not be more than **three years old** from the date of initial registration and must have valid **Registration Certificate, Insurance Certificate, Fitness Certificate Valid contact carriage permit, proof of up to date tax payment which are mandatory for applying of vehicle.**
02. The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficient experienced in driving transport passenger vehicle.
03. The Driver should be well behaved, gentle and obedient in nature.
04. A sum of **Rs.5000/-** shall be deposited by the intending bidders in shape of Account Payee Bank Draft/cheque drawn in favour of the General Manager, DIC, Phulbani and submitted along with the Tender Paper as security deposit. 
09. Initially the vehicle shall be engaged up to January'2020.




