Sealed quotations/ tenders are invited from interested private individuals for providing **02(Two)** no. of Non AC/ AC diesel driven vehicle (**Bolero/TUV/Bolero Neo**) having minimum sitting capacity Seven, including driver which shall confirm to the terms and conditions as detailed below for official use one under **MGNREGA and Rural Housing** Scheme in **Panchyat Samiti , Phiringia , Kandhamal** on monthly rent basis .

1. The vehicle must be in road worthy condition and must have valid registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment, etc which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel)
5. The vehicle must achieve a fuel efficiency of **12 kms** per litter.
6. The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms covered per litter) and name of the driver with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/ tender (Annexure –III).
7. The quotation completed in all respect should reach the undersigned on or before **26.07.2023 by 2.00 PM** and shall be opened on **27.07.2023 at 11.00 AM** in presence of the bidders or their authorized representatives.
8. The quotation documents completed in all respect must be submitted by the bidder through Registered Post/Speed Post/Courier Service only address to the Block Development Officer, Phiringia.
9. The quotation received beyond the stipulated date and time and incomplete quotations in any respect shall not be taken in to consideration

and liable for rejection. The office shall not be responsible for any postal delay.
