

Sealed quotations are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing One (1 no.) AC (Diesel or Petrol) driven vehicle specifically Bolero Neo having seating capacity not more than ten (10) persons including driver, which shall conform to the "Terms and Conditions (Annexure-I)" for official use, For Nayagarh district under office of the Mining Officer, Phulbani Circle, Phulbani on monthly rent basis.

1. The vehicle must be in Road Worthy-condition, shall not be more than 3 years old (preferable new) from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of the Mining officer, Phulbani and submitting along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charges be quoted separately in the general bid information. (Excluding Fuel cost). Maximum allowed hire charges per month is Rs.31, 000/-(Excluding Fuel cost) including GST.
6. The vehicle must achieve a fuel efficiency of 10Kms per liter.
7. The details of the make and year of manufacture of the vehicle, registration No., mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure- II).
8. The application form of quotation/tender containing General Bid information (Annexure-II) & Terms and Conditions (Annexure-I) etc. for hiring of vehicle will be available with the Mining Officer, Phulbani Circle, Phulbani on payment of Rs.100/-(non-refundable) from 21.07.2023 to 08.08.2023 up to 1.00 P.M. on all working days. All the documents must be inserted in the sealed envelope, along with the applicants name and address super scribed on the envelope and clearly marked the "**Quotation/Tender Call Notice for hiring of vehicle for Nayagarh district**" on the top of envelope.

The Quotation completed in all respect should reach the undersigned on or Before 08.08.2023 by 1.00 P.M. & shall be opened on the same day at 3.00 P.M. for Nayagarh district in presence of the bidders or their authorized representatives. If this day is declared later as a Government holiday then the tenders will be received and opened on the next working day as per the schedule time. The undersigned will not be held responsible regarding late submission/receive of tender in any manner.


