




Eligibility Criteria

1. The Firms/Artist must possess experience in similar type of work in Govt. sector.
2. The Firms/Artist must have its office inside the State of Odisha.
3. The Firms/Artist should furnish a certificate that it has not been black listed anywhere.
4. The Firm/Artist should submit of their credibility and experience.

Teams and Conditions

1. The Expression of Interest documents must be accompanied with EMD of Rs. 15,000/- in shape of DD drawn in favour of Project Administrator, ITDA, Phulbani Payable at Phulbani.
2. The envelope containing the documents must be super scribed "EOI for Tribal wall painting.
3. The EOI completing in all respect must reach the Project Administrator, ITDA, Phulbani by 08.02.19 at 5 P.M. PM through Speed Post/ registered Post/ Courier which shall be opened on 11.02.19 at 11.30 Am. AM in presence of the bidders/ their authorized representatives.
4. The firm/ individual artist must ensure the durability of paintings for a period of at least 2 years. The exterior paints of good quality which can withstand the weather, excessive heat and rain, dust etc must be used. Ant deviation in this regard will liable the concerned firm for forfeiture of their security deposit.
5. The Collector- Cum-CEO, SDC, Kandhamal reserves the right to cancel the contract of successful firm at any point of time without assigning any reason thereof.
6. The bidder must have experience of completing 3projcts in tribal wall painting with a maximum extract of 2000Sq.Ft.
7. The bidder preferably should be local of Kandhamal for work effectiveness.
8. The tribal wall painting will be done in 12 blocks of Kandhamal District in various Govt. buildings & compound walls. The approximate funds for the activity will be Rs. 30 Lakhs.

9. The bidder must submit a conceptual art proposed with at least 15 images related to tribal culture.
10. Self certificate that firm is not black list by any Govt.
11. Documents like PAN, GST must be submitted. The committee may consider exemption of GST, PAN incase of individual entrepreneuring artist & tribal artist group.
12. The bidder may furnish rate per Sq. Ft. irrespective of different type of images inclusive of cost of coulor, labour, accessories and all other expenses.
