The Project Administrator, ITDA Balliguda on behalf of Government of Odisha, invites e- tender (non- composite bids) in conformity with the detailed tender call notice from the contractors registered with the State Government and equivalent grade /Class registered with the Central Government / MES/ Railways, having registration for civil & electrical works or contractors having registration for Civil works only of specified category as noted against each work to be eventually drawn – up in PWD From –P1 (Percentage Rate bids) for different works along with detailed particulars as noted below in the table.

2. The bidders may submit bid for the following works.

4. Bids must be accompanied by Earnest Money deposit/Bid Security of the amount specified for the work in the table at Col.5 above, pledged in favour of **Project Administrator, ITDA, Balliguda** as specified for the work at Col.-02 of above table and will have to be in any one of the forms as specified in the bidding documents. Bidders desirous to hire machineries or equipments from outside of the State or owned but deployed outside the State are required to furnish 2% of the amount put to tender as Bid security.

5. The Bid documents will be available in the website: <https://tendersorissa.gov.in> from **11.00 A.M. of 14.02.2019 to 5.00 P.M. of 21.02.2019 for online bidding.**

6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.

7. Bids shall be received only through **"on line" on or before 5.00 P.M. of 21.02.2019.**

8. Bids received **on line** shall be opened at **11.00 A.M. on 23.02.2019** in the office of the **Project Administrator, I.T.D.A., Balliguda** in the presence of Members of Tender Committee and the bidders or his/her authorized representative. The documents submitted through e-tender must be produced in original by the bidders or his/her representatives **on 11.00 A.M. to 5.00 PM of 22.02.2019.** If the office happens to be closed on the fixed for date of opening of the bids as specified, the same will be opened on the next working day as per the scheduled time and venue.

9. The bidder shall provide the cost of bid/bid security/EMD in original along with the Affidavit/copy of PAN/GST Clearance/Labaour licence if any/Price preference if any /Caste Certificate of SC & ST Contractor in a sealed cover super scripting the name of work and officer inviting the bid. He/She should not write his/her name on the cover. The sealed cover containing the cost of bid and the bid security & EMD in original shall be physically produced before Project Administrator, ITDA, Balliguda **on 11.00 A.M. to 5.00 PM of 22.02.2019** or may send through Registered Post/ Speed post/by hand only in the office address which should reach in due time as mentioned above . The Project Administrator, ITDA, Balliguda will not be responsible for any postal delay or loss.

10. If the bidders or his representatives fails to produce the original documents, EMD in shape of NSC/TDR/KVP/Fixed deposit receipt of Nationalised Bank/Postal Deposit **(as per table col.no.5)** and the cost of tender paper in shape of demand draft **(as per table col.no.6)** his bid shall not be taken into consideration.

11. The cost of bid documents shall be deposited in shape of demand draft of any Nationalised Scheduled Bank duly pledged in favour of Project Administrator, I.T.D.A., Balliguda **(as per table at col.no.6)**.

12. Financial instrument such as cost of bid document and bid security in original shall have to be deposited in the office of Project Administrator, I.T.D.A., Balliguda **on 11.00 A.M. to 5.00 PM of 22.02.2019**, failing which the bids shall be summarily rejected. Non submission of cost of bid document and bid security within the stipulated period shall debar from participating in the online bidding system and his portal registration shall be cancelled. His name shall also be informed to the registering authority for cancellation of his registration.

Special Clause :

13(a). The successful bidders shall have to deposit the full differential amount i.e **(The difference between the amount put to tender and the quoted amount) as Additional Performer Security Deposit (APSD)** in shape of NSC/TDR/KVP/Fixed deposit receipt of Nationalised Bank/Postal Deposit duly pledged in favour of Project Administrator, I.T.D.A., Balliguda at the time of Agreement or else the bid of the successful bidder will be cancelled and the Security deposited will be forfeited and further proceeding for blacklisting will be initiated as per law, in accordance to Letter No. 13286/W dated 07.09.2017 of Government of Odisha, Works Department.

(b). The Contractors whose agreement time is over and not applied for extension of time for the previous works awarded by of ITDA, Balliguda shall be debarred from the e-procurement tender process.

(c). The Contractors whose agreement have been cancelled due to non-execution of work within the stipulated time for the previous works of ITDA, Balliguda shall also be debarred from this e-procurement tender process.

14. Bidder has to submit an undertaking in the form of Affidavit in Non-Judicial stamped paper of requisite amount indicating the authenticity of his documents submitted/uploaded tender papers as well as his claim of relaxation as per norms separately.

15. Other details can be seen in the bidding documents.

16. Engineer Contractors desirous to avail the facility of exemption of EMD is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year . The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected. Similarly, ST/SC Contractors seeking price preference required to produce an affidavit to this effect. The ST/SC Contractors having Degree/Diploma in engineering are not allowed to be avail both the benefits. The scan copy of affidavit will be submitted in website at the time of submission of bid with the tender papers. Further, price preference will be considered as per Notification No. 16/37-27748 dated 11.10.1977 of Government of Odisha , Works Department.

17. The Contractor who have not submitted genuine documents in the previous tender will be debarred to participate in the Tender process.

18. The authority reserves the right to cancel any or all bids without assigning any reasons thereof.
