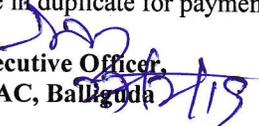

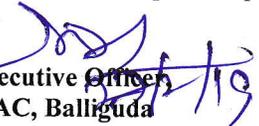

TECHNICAL BID

1. General Terms & Conditions:

- (i) Notified Area Council, Balliguda invites sealed tenders in two-bids (1. Technical & 2. Financial) format from the registered firms / Entrepreneurs / Authorized Dealers/ Authorized Distributors/ Private Companies towards supply sanitation items as per specification given in DTCN to the Office of the NAC, Balliguda for the FY 2018-19/2019-20.
- (ii) The bid is meant for supply of DG Set as specified in the tender. Balliguda NAC shall have right to float any comprehensive bid during the contract period and no party will have right to challenge it.
- (iii) The guarantee period of the above Silent D.G. Set Generator must be mentioned in the quotation paper with an under taking that the Silent D.G. Set Generator will be replaced/returned immediately, if found any defect within the guarantee period.
- (iv) The supplier will supply and install the silent D.G. Set Generator at Balliguda NAC on issue of supply order at his own risk within the stipulated period.
- (v) The materials will be inspected by the Executive Officer/Electrical Store-In-charge of Balliguda NAC.
- (vi) The brand of liquid cooled engine should be reputed make with 1500 rpm, 50 Hz, 0.8 pf, 415 V.
- (vii) The DG Set must be of Central Pollution Control Board - II (CPCB - II) Compliant.
- (viii) The Principal Company must cover the Warranty features adequately / comprehensively for 2 Years / 5000 Hours on its each part / component from the Date of Commissioning of DG sets.
- (ix) There should be Extensive Warranty features, at least for 3 Years, (apart from 2 years of Standard Warranty) on the Critical Components of Engine, such as Cam Shaft, Crank Shaft, Cylinder Block, Cylinder Head and Connecting Rod.
- (x) The minimum time of Service Interval of a DG set should be of 500 Hours / 1 Year.
- (xi) Acoustic Enclosure should undergo 11-tank pretreatment process with Ultra Violet resistant powder coating before fitting to the DG Set.
- (xii) Balliguda NAC shall have the right to terminate the contact on the ground of supply of poor quality material.
- (xiii) Tender document is available at the website <http://www.kandhamal.nic.in/>. Tenderer shall be required to deposit earnest money (EMD) for an amount of Rs 10,000/- (Rupees Ten Thousands only) refundable and non-refundable tender fee for an amount of Rs.4,000/- (Rupees Four Thousands only) by way of demand draft from a nationalized bank drawn in favour of " Executive Officer, NAC, Balliguda " payable at Balliguda. The demand drafts for earnest money deposit & tender fee must be enclosed in the envelope containing the technical bid. Earnest money deposit shall be forfeited if the tenderer withdraws its bid during the period of tender validity.
- (vii) Offers in the financial bid should be written in English and price should be written in both figures and words. Where ever, if there is difference between the rate quoted in figures and words, the rate quoted in word will be taken as correct. The offer should be typed or written in pen ink or ball pen. Use of pencil will be ignored. Bids containing over writing/ additions/obliteration & and other discrepancies should be properly attested by them.

- (xiv) Technical & financial bid envelopes should be individually sealed and then placed in a third envelope to be sealed and super scribed with tender call notice number, due date of submission. Bids received beyond last date of bid submission will be rejected. No tender will be entertained by E-mail / FAX. The tender shall be submitted through RP/Speed Post/Courier in a sealed envelope bearing the following reference on the top left corner:“ Tender Notice No.:.....429/27.02.2019.....” latest by **11TH March 2019 at 5.00 PM and addressed to:“The Executive Officer , Notified Area Council, Balliguda – 762103 ”.**
- (xv) At any time prior to the deadline for submission of bids, NAC, Balliguda may, for any reason at its own initiative modify the tender document by amendment.
- (xvi) The amendment will be published on the office notice board of Balliguda NAC. In order to afford prospective tenderer(s) reasonable time in which to take the amendment into account in preparing their bid, Balliguda NAC may, at its discretion extend the deadline for the submission of tender.
- (viii) Technical bid will be opened on **12th March 2019 at 11 A.M.** at Balliguda NAC office in the presence of the tenderer or their authorized representative, who are present at the scheduled time & financial bids will be opened on the same day at 12.00 AM. Financial Bids of only those Tenderers will be opened, who qualify in Technical Bid.
- (ix) In the event of the due date of receipt and opening of the tender(s) being declared as holiday for the Institute, then due date of receipt / opening of the Tender will be the next working day at the same time.
- (x) The tenderer(s) are requested to read the tender document carefully and ensure compliance with all the instructions herein. Non-compliance of the instructions contained in this document may disqualify the tenderer from the tendering exercise.
- (xi) Any amendment and / or addition made to the tender are not permissible after opening of the tender, incomplete tender(s), will be rejected.
- (xii) Balliguda NAC reserves the right to reject any or all tender(s), wholly or partly or close the tender at any stage prior to award of contract without assigning any reason whatsoever.

2. Eligibility Criteria:

1. The Tenderer should have Valid Regn. Certificate/ Dealer Certificate/ Manufacturing license.
2. The Tenderer should have up to date GST clearance Certificate.
3. The Tenderer should have Valid PAN
4. The Tender have Income Tax clearance certificate.
5. The tenderer has not been debarred and / or blacklisted by any Central Government and / or any State Government Department(s) and / or any PSU and the tenderer should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs 10/- duly notarized shall be enclosed with the technical bid. The affidavit will be in the format enclosed with tender as Appendix-B
6. Letter of authorization for representing the Reg. Firm etc. & to sign the bid document should be enclosed along with the bid document.

3. Earnest Money Deposit:

The earnest money deposit of the tenderer, whose tender has been accepted, will be returned after successful completion of the contract period. Earnest money deposit of the successful tenderer shall be forfeited, if one refuses or neglects to execute the contract or fails to supply the required materials within the time frame as specified by Balliguda NAC. After the award of the contract to successful tenderer, the earnest money deposit of all other tenderer(s) will be refunded within 30 day whose offers have not been accepted.

4. Evaluation:

4.1 Technical Bid:

- (a) The Technical bid will be in the format enclosed with tender as **Appendix - A** in separate sealed cover. All the self-attested supporting documents should be attached with the Technical bid.

4.2 Financial Bid:

- (a) The financial bid will be in the format enclosed with tender as **Appendix - C** in separate sealed cover. Failure to provide price bid in a sealed separate cover will result in invalidation of the offer.
- (b) Offers in the financial bid should be written in English and price should be written in both figures and words. Where ever, if there is difference between the rate quoted in figures and words, the rate quoted in word will be taken as correct. The offer should be typed or written in pen ink or ball pen. Use of pencil will be ignored. Bids containing over writing/ additions/obliteration & and other discrepancies should be properly attested by them.
- (c) The quoted rate should be inclusive of all taxes & transportation charges.
- (d) The financial bids shall be opened for those bidders who qualify after the evaluation of Technical bid. It shall be evaluated on the basis of lowest rate quoted by tenderer(s). The bidder who has quoted lowest rate will be selected.

5. **Award of Contract:** After due evaluation of the financial bids, Balliguda NAC will award the contract to the lowest tenderer (hereinafter referred to as the "Contractor").
