





1. The intending Farmers Organisation/Producer Company/Farmer Groups must have valid Certificate of Registration with GSTIN Number.
2. Priority should be given to the Farmers Organisation/Producer Company/Farmer Groups those have the work experience in Kandhamal district.
3. Defaulter Company, Firms/Society/Trust will not be entertained.

**Submission of Documents:**

1. Submission of Proposal along with the quoted price of each plants (including transportation to the field area)
2. Declaration the capacity on nos of lemmon grass plants to be supplied with in the limited periods (Maximum 15 days).
3. Farmers Organisation/Producer Company/Farmer Groups profile along with the registration certificate and details of current activities and management structure.
4. The Paper Cost of Rs-3,000/- shall be deposited in shape of BD/ BC in any nationalized bank in favour of Project Administrator, ITDA Balliguda.

5. The earnest money deposit (EMD) of Rs.20,000/- (Rupees Twenty Thousand) only, refundable (without interest), should be necessarily accompanied with the tender paper in the form of demand draft/ pay order drawn in favour of Project Administrator, ITDA, Balliguda **failing which the tender shall be rejected summarily.**

The successful bidder shall have to deposit security money Rs-1,50,000/- (One Lakhs Fifty Thousand) in shape of TDR duly pledged in favour of Project Administrator of ITDA, Balliguda from any nationalized bank, before execution of the agreement.
