

## TERMS & CONDITIONS

1. Interested bidders may submit their sealed tender documents in the prescribed format mentioning "Supply of Sports Goods" on the cover of the envelope to the District Sports Officer, Kandhamal by 06.11.2019 up to 4.00 P.M. Bidders are required to submit technical bid and financial bid in separate envelope enclosed in a common envelope mentioning "Supply of Sports Goods" on the cover of the envelope through Regd.Post/Speed Post only addressing to the District Sports Officer, Kandhamal Stadium, Phulbani, Kandhamal.
2. The Tender papers in details along with prescribed tender schedule can be obtained on payment of Rs.500/- (Rupees Five hundred) only (non refundable) from the office of the District Sports Officer, Kandhamal, Phulbani and money receipt will be received from the Sports Hostel, Phulbani on cash payment from dtd.21.10.2019 to 06.11.2019 in any working days from 11.00 A.M. to 4.00 P.M. and in support of such purchase money receipt thereof will be attached along with the Tender form. Tenders received after due date and time will not be accepted. District Sports Officer, Kandhamal, Phulbani shall not be responsible for Postal delay or similar reasons. No Tenders sent through an electronics means shall be accepted. Any corrigendum/ addendum, if any will be uploaded in the above mentioned website.
3. The Tender Paper should be filled in properly by the tenderer without correction/overwriting. The rate quoted by the tenderer should be final and tenderer should not be allowed to change anything under any circumstances. The Tender Paper should be completed in all respect. Incomplete tender paper is liable to be rejected. All the documents must be self-attested by the Bidder.
4. The tenderer are required to deposit the EMD amount of Rs.5,000/- (Rupees Five thousand) only in shape of Bank Draft drawn in favour of Collector, Kandhamal payable at Kandhamal along with the tender documents (subject to refund of the same to the unsuccessful tenderer) after selection/finalization by the Tender Committee.
5. Bidder must submit the copy of PAN Card, Income Tax Return of 03 Financial Year, GST Registration Certificate along with self attested photo copy dealership Certificate/Authorized supplier with validity up to financial year 2019-20 Registration Certificate in case of manufacturer participating as a bidder. Bidder must submit the VAT Clearance Certificate.
6. The Coach In Charge, Sports Hostel, Phulbani will be considered strictly on the basis of the quality of the sample of Sports goods submitted by the bidders which will be evaluated by the Tender Committee. If the Technical Bid is found complete in all respect, then only Financial Bid will be opened, otherwise Financial Bid will be returned to the bidder without opening it. The purchase order shall be placed as per actual requirement as well as availability of funds. Order shall be placed with the approved supplier(s) taking into consideration of trainees strength. The selected tenderer should supply the materials in the office of the Sports Hostel, Phulbani within 15days (Fifteen days) from the date of issue of supply orders, strictly as per the sample approved by the Purchase Committee.

7. Selection of bidders to supply the items is the sole discretion of the Purchase Committee. No bidder shall be entertained without sample at the time of Opening of bid. The sample produced by the bidders at the time of Opening of bid shall be examined by the Committee at first and then the rate of the items shall be considered among the selected samples only.
8. A bidder may bid one or more than items at a time and single bidding form for all the items shall be valid.
9. In case of any complaint regarding the supplied materials the decision of the Additional District Magistrate, Kandhamal shall be binding and final. Who shall obtain a report from the recipients then the suppliers shall be replaced the same at his/her (their) own cost.
10. The suppliers shall be responsible for any damage/loss during transit to delivery point.
11. No request for enhancement of approved rates shall be entertained for the period once the Agreement is signed.
12. The Additional District Magistrate, Kandhamal may at any point time terminate the contract for violation of terms and conditions of Agreement without notice or in case the supplier has produced forged/fabricated/unauthentic documents.
13. All tenderers are required to quote price of different brands of materials in the Bid Schedule.
14. The Tender rate must be inclusive of all types of taxes, Transportation charges to supply the Sports materials to the Sports Hostel, Phulbani.
15. The Sealed Tender Paper will be received by Speed Post/Registered Post to the Sports Hostel, Kandhamal Stadium, Phulbani during office hours i.e from 11.00 A.M. to 4.00 P.M.
16. The Additional District Magistrate, Kandhamal reserves the right to reject any or all the bid received without assigning any reason thereof.
