Sealed tenders are invited from the eligible bidders as per the eligibility criteria for supply of Delivery Van under ZSS, Kandhamal.

1. The bidders have to submit their tenders in separate sealed covers (i.e. Cover "A"- Technical Bid & Cover "B"- Price Bid). Both the covers should be put into a third Cover "C" which must be super-scribed as "Tender for "supply of Delivery Van".
2. **The Cover "A" (Technical Bid) should contain as follows: -**
 - a) Checklist with details of the documents enclosed in Cover "A" (as per Annexure - I) with page number. The document should be *serially arranged* as per this Annexure - I and should be securely tied and bound.
 - b) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a **Notary Public (Annexure – IV)**.
 - c) EMD **Rs.20,000/-** (Rupees Twenty Thousand only - **Refundable**) in shape of Bank Draft / Bankers Cheque in favour of ZSS Non NHM Fund A/C payable at Phulbani.
 - d) Tender Paper Cost **Rs.2000/-** (Rupees Two Thousand only – **Non-refundable**) in shape of Bank Draft / Bankers Cheque in favour of ZSS Non NRHM Fund, Kandhamal payable at Phulbani.
 - e) The specification of the Delivery Van should be as follows:
 - Truck (CBC Variant).
 - Build Cargo work full body with door & window and should be well covered for privacy of the Mother/patient.
 - Total Body Color Paint, Stickers, First aid kit & Glowing Siren.

- n) They should quote the rates inclusive of insurance, packing, forwarding, freight (door delivery) and GST (if any) and should submit a self declaration about this.
- o) They must submit the undertaking that they will supply the stocks **within thirty days** after receipt of the Purchase Order from this office.
- p) The supplier shall have a minimum average turnover of Rs. 50 Lakh or more in the last three year financial years i.e. 2016-17, 2017-18 & 2018-19 and copy of the audited financial statement for the last three financial year i.e. 2016-17, 2017-18 & 2018-19.

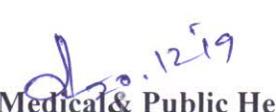
3. General Condition:

- c) A Pre-bid meeting will be held on the stipulated date & time in the O/o. CDM& PHO Kandhamal.
- d) Violating the tender terms and conditions & non-supply / partially supply / supply, which is not as per technical specification, will declared as **Blacklisted** and disqualify the firm to participate in any tender of this district for a period of next 03 (three) years from the date of issue of the letter and their E.M.D. will be forfeited.
