

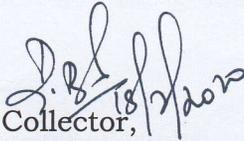

The sealed tender will be opened on 18.03.2020 at 11AM by the undersigned in his office in presence of the tenderers or their authorized agents and Dist. Level Tender Committee constituted for the purpose.

There shall be two stages of bidding - Technical & Financial . Interested tenders must submit their technical bid and financial bids in separate envelope superscribed as financial and technical bid respectively . These two envelopes must be placed in a third bigger envelope superscribed as "tender bid for printing and supply of New Arunima work book 1&11" in Kandhamal District.

The tenders received beyond the scheduled time and date shall be rejected. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof.

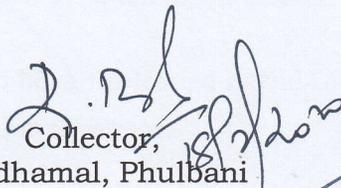

## Terms & Conditions:

1. Sample copy of New Arunima Work Book I & II for pre-school children as prescribed by the Govt. in W&CD Deptt. are attached herewith
2. The Collector reserves the right to reduce/enhance the quantity or items stated above during indent taking into consideration of availability of funds for the purpose.
3. The cost of New Arunima Work Book I & II should be inclusive of all taxes /GST (Including transportation charges & loading unloading till delivery at project office) within specified period.
4. The quality of the papers of New Arunima Work Book I & II should be in conformity with the specification mentioned. District level purchase committee constituted for the purpose will check the quality of papers of the Arunima work book I & II ,covers during the selection of tender. The sample of selected tender will be preserved to compare with the New Arunima Work Book I & II delivered at District.
5. In case of the disputes about the quality of the New Arunima Work Book I & II supplied Collector will cause an enquiry and take suitable action including debarment against the supplier.
6. The whole or part of the Security Deposit/EMD will be forfeited for irregular performance or breach of any term(s) and condition(s) of the tender.
7. The tenderers should deposit EMD of Rs.25,000.00/- (Rupees Twenty five thousand) only in shape of Bankers Cheque duly pledged in favour of DSWO, Kandhamal. Tenders without Earnest Money will be liable for rejection.
8. Earnest Money deposited by the successful tenderer will stand converted to security deposit, which will be refunded after successful completion of supply and audit of accounts of the Supplier by the Deptt. Audit.
9. Earnest Money of unsuccessful tenderers shall be refunded after finalization of the tender.
10. The detail of the tender for Arunima Work Book I & II has also been up-loaded in the Dist. NIC, website. ([www.kandhamal.nic.in](http://www.kandhamal.nic.in)) which may be down-loaded for reference.

11. Payment shall be made against submission of bills on completion of delivery of New Arunima Work Book I & II as per the orders of the competent authority along with receipt of supply certificate from concerned CDPOs.

12. The Collector shall have the right to deduct any amount found recoverable towards inferior quality, loss and damage etc. from the bill for supply of New Arunima Work Book I & II . The supplier for delay in payment of the bill shall not claim any interest. No advance payment will be made before supply.

14. Conditional tender will not be accepted.

15. Intending Agency should submit the sample with quotation to the district office .Without sample tender will not be accepted.

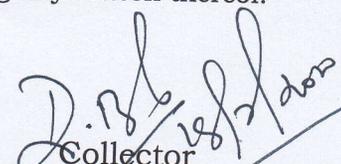
16. The New Arunima Work Books I & II should be delivered by the suppliers / firm with 30 days from the date of issue of supply orders failing which daily penalty of 2% of the billed amount will be charged every 7 days for delay beyond the specified date of supply.

17. There shall be two stages bidding:-Technical & Financial bidding.

The tender shall accompany the following documents:

- a. The Bankers Cheque of Rs.3000/- (Rupees Three Thousand) only duly pledged in favour of DSWO, Kandhamal towards cost of tender paper.
- b. Original tender paper duly self attested by the tenderer as token of acceptance of the terms and conditions.
- c. Self attested Copy of Income Tax clearance certificate for 3 Years (2016-17, 2017-18 & 2018-19).
- d. Self attested copy of Xerox copy of the registration certificate of the unit.
- e. Self attested Xerox copy of PAN , TAN Card and Adhara card.
