QUATATION / TENDER CALL NOTICE

Sealed quotations are invited from interested reputed Travel Agencies / tour operators or private individuals for providing new vehicle (with in three months from the date of purchase to tender date) (TUV 300/Bolero/Sumo Gold/Ertiga) with Air Conditioner facility which shall conform to the Term and Conditions (Annexure-I) for official use in Panchayat Samiti, Balliguda on monthly rent basis, preference shall be given to 7(seven) seated new vehicle. The maximum price limit of the hire vehicle is Rs.31,000/- per month excluding POL.

- 1) The vehicle must be in road worthy condition shall not be more than (with in three months from the date of purchase to tender date) and from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness certificate, Valid Contract Carriage permit, Proof of up to date tax payment etc. which are mandatory for playing of vehicle. Xerox copies of these documents should be submitted along with the quotation.
- 2) The good condition vehicle having lowest price shall be given preference.
- 3) The Driver of vehicle must have a valid Driving license for Driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle. The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs. 5,000/- (Five thousand) only shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favor of the Block Development Officer, Balliguda and Submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge should be quoted separately in the general bid information (excluding fuel and lubricants) in Annexure- II.
- 6) The Vehicle must achieve a fuel efficiency of 10 kms per liter.
- 7) The details of the make and year of manufacture of the vehicle, registration, mileage (Kms. covered per liter) and name of the Driver with Driving License No and period of Validity should be specially provided in the general bid information to be furnished with the Quotation/ tender (Annexure - II)
- 8) The Quotation completed in all respect and duly signed by the bidder in Annexure- I & II should reach the undersigned on or before 20.05.2020 by 11.30 AM through RP with AD/Speed post only and shall be opened on the same day at 12.30 P.M in presence of the bidders or their authorized representatives if any.







TERM & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles during a contract, shall have all necessary valid MV documents such as :- Valid registration Certificate, Insurance certificate, Valid Contract carriage Permit, proof of up to date tax payment etc. and DL of the Driver available all the times. The department/office hiring the vehicles or loss of life/ injury made to any person damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel which is to be paid separately basing on actual consumption and lubricants are per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating Oil of Engine, Gear Box and differential Coolant Tries & tubes Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case breakdown for reason whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
5. In case of the vehicle do not report regularly. The Authority will be at liberty to reject the agreement and may engaged vehicle from other source.
6. In case of emergency, the driver will be to report for duty as per the requirement of hirer. No extra payment shall be demanded.
7. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month as per as possible with in fifteen days of the submission of bills by the service provider and no advance payment will be made.
8. The vehicle shall not be more than three month old from the initial registration and also in good running condition during the period of contract.
9. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
10. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such with drawl of service and termination of agreement.
