## Quotation Call Notice

Sealed quotations are invited from the registered suppliers for supply of Printed T- Shirt for COVID Monitor of kandhamal district for COVID -19.


1. The supplier have to submit their quotations in separate sealed covers which must be super-scribed as "**Quotation for supply of Printed T- Shirt for COVID Monitor**".
2. **Technical Bid should contain as follows:**
  - a) The document should be **serially arranged** and should be securely tied and bound.
  - b) Copies of organization PAN.
  - c) Photocopy of the GST Registration Certificate and GST return copy for the month of January to March – 2020.
  - d) Copy of organization Income Tax Acknowledgement Report (**Assessment Year 2017-18, 2018-19 and 2019-20**).
  - e) Last Purchase Order Copy of similar items.
  - f) **The bidder must submit the Smaple copy of the T- Shirt with their quotations.**
  - g) They should quote the rates for inclusive of insurance, packing, forwarding, freight (door delivery) and GST charges (if any).
  - h) Eligible bidders should submit their quotation documents to the CDM & PHO, Kandhamal through **Speed Post / Registered Post/ courier/Drop Box on or before 31.07.2020 by 03.00 PM and will be opened on the same day i.e. 31.07.2020 at 04.00 PM.**

3. **Price Bid should contain as follows:**

- a) Financial Bid must be submitted in the prescribed format as attached in **Annexure- A**. No other document should be enclosed in the Financial Bid.
- b) The rates should be computerized.
- c) The price quoted by the bidders shall not exceed the MRP.
- d) The price quoted by the bidders including all taxes.

The last date for submission of the quotation documents is fixed on **31.07.2020 by 03.00 PM**. and will be opened on **31.07.2020 at 04.00 PM** by the purchase committee in presence of the bidders.
