

03. The tender papers shall have to submitted in a sealed cover each work separately through registered post/speed post in the addressed of block development Officer, Khajuripada and he should mention 'TENDER PAPER FOR PANCHAYAT SAMITI' only without mentioning the name of the work in the top of the cover.
04. The tender paper should accompany attested Xerox copies of valid and registered License. Up-to date Income Tax Clearance Certificate, GST certificate, PAN card and also an affidavit mentioning the authenticity the document submitted.
05. SC/ST contractors should submit attested Xerox copy of cast certificate and an undertaking in shape of affidavit to get exemption from EMD.
06. The EMD to be deposited should be duly pledge in favour of the Block Development officer, Khajuripada in shape of NSK/KVP/POTD or in shape of Bank Draft/Banker Cheque pledged in favour of the Block Development Officer, Khajuripada payable at Khajuripada along with the tender document.
07. Engineer Contractors seeking exemption of EMD should produce the Original contract license before the tender opening authority for verification and he should submit an affidavit to the effect that he has not been awarded with more than three works without EMD in the current financial year.
08. Transfer or adjustment of EMD/Differential amount/Initial security Deposit (ISD) will not be entertained.

Additional performance security shall be deposited by the successful bidder when the bid amount is seriously unbalanced i.e. less than the tendered amount by more than 10% In such an event the successful bidder will deposit the additional performance security to the extent the differential cost of the bid amount in shape of bank Draft/Banker Cheque drawn in favour of the Block Development Officer, Khajuripada payable at Khajuripada at the time agreement.
10. The sealed tender paper can also be sent to the undersigned through registered Post/Speed Post only.


